1. Call to Order

Mayor Currin called to order the workshop meeting of Hudson City Council at 7:30 p.m. and turned the meeting over to President of Council DeSaussure.

2. Correspondence and Council Comments

Mr. Basil announced that the next Ward 2 Open Forum will be held at 7:30 pm. on Monday, January 27, 2014, at the Barlow Community Center.

Dr. Williams provided a report on the January 16, 2014, Cable Television Advisory Committee meeting. He said that the Committee continues to raise money, noting recent grants received from the Rotary Club of Hudson and the Burton D. Morgan Foundation. He also noted a significant increase in the amount of HCTV programming in 2013.

Mr. Wooldredge said the Economic Growth Board will not meet on January 23, 2014, due to the Ad Hoc Downtown Phase 2 Committee being scheduled that same evening.

Mr. DeSaussure announced current vacancies on the Tree Commission and Personnel Advisory and Appeals Board and said the City will accept applications through February 5, 2014.

A. 14-14 A RESOLUTION AUTHORIZING A HOMELAND SECURITY RADIO GRANT APPLICATION; AND DECLARING AN EMERGENCY.
