#### 1. Call to Order

In the absence of Mayor Shubert, President of Council Wooldredge called to order the meeting of Hudson City Council at 6:30 p.m., in accordance with the Sunshine Laws of the State of Ohio, O.R.C. Section 121.22.

#### 2. Executive Session

It was moved and seconded that Council enter into executive session to consider a personnel matter concerning appointments to various boards, commissions, and committees and to conduct interviews therefore. Mr. Wooldredge recessed the meeting at 6:31 p.m. after the motion was approved by unanimous voice vote.

Mayor Shubert entered and reconvened the meeting at 7:30 p.m.

#### 5. Approval of the Minutes

#### A. <u>20-0156</u> Minutes of Previous Council Meetings

#### 6. Public Comments

Mr. Ron Brubaker, 7593 Partridge Meadows Drive, Co-Director of Trail Advocates of Summit County (TASCforce.org), spoke to Council regarding the importance of converting the inactive Metro RTA right-of-way into a multi-purpose trail from Hudson to Akron (also known as the Veterans Trail proposal) and of the group's opposition to a proposal to reactivate the rail line. He said that TASCforce is petitioning Metro RTA to dismiss the rail line reactivation proposal and embrace the multi-purpose trail proposal. He asked that Council submit a letter endorsing a multi-purpose trail and opposing the reactivation of rail service along the right-of-way (see sample letter attached to record copy of these minutes).

#### 7. Correspondence and Council Comments

Mayor Shubert shared that his wife has been diagnosed with lymphoma, and he asked all to please keep Sherry in their thoughts and prayers. All Council members expressed compassion and concern for Sherry's health. They offered to keep the Mayor and his wife in thought and prayer and offered assistance in whatever way needed.

Mr. Foster referred to recent concerns expressed by residents regarding safety at various intersections in the City, and he asked staff to research improvements and schedule this topic to a future Council workshop. In addition, he asked staff to propose a solution for the railroad underpass on Owen Brown Street, suggesting traffic restrictions that would allow for a sidewalk. He also thanked Ms. Howington for joining him in a meeting with a concerned resident earlier in the day.

Mr. DeSaussure supported Mr. Brubaker's proposed action concerning the Metro RTA "Rails to Trails" proposal, and he asked that this matter be scheduled for future discussion. There was consensus among the

remaining Council members in support of this.

For improved pedestrian safety at traffic intersections, Mr. Wooldredge proposed a separate traffic signal cycle for pedestrian crossings.

Ms. Schlademan said that the City's Traffic Safety Committee is considering the intersections of concern, and she supported further discussion. She also thanked City staff, elected officials, and board, commission, and committee members for their dedicated service especially during the last year, which has presented unique challenges with COVID-19 meeting restrictions. She wished everyone a safe, happy holiday and new year.

Responding to Council comments, Mr. Sheridan provided information regarding the Rails to Trails proposal and said that staff will be prepared for further discussion at an upcoming workshop. Regarding intersection concerns, he noted that the Traffic Safety Committee will review these matters at their meeting on January 7, 2021, and he will provide a report to Council prior to their workshop discussion. He said that traffic improvement to the Owen Brown Street underpass is budgeted, and sidewalk installation is scheduled.

#### 8. Report of Manager

On behalf of City staff, Ms. Howington offered Mayor Shubert her thoughts, prayers, and help as needed during these difficult times.

She also shared that the City's Senior Citizen Advisory Committee is trying to keep local seniors connected during the pandemic with periodic drive-through events. They also are checking-in with seniors, offering remote learning opportunities, and encouraging safe interaction.

She congratulated the Mayor and Council on their ability and willingness to expand the City's road program during 2021 and for being dedicated to funding the Connectivity Program, as well as many important stormwater projects, and for supporting technology improvements, such as adaptive traffic signals.

She thanked staff for providing services during the pandemic and for being flexible to new ways of meeting the needs of citizens.

#### A. 20-0157 Police Department Update

**<u>Brief Description:</u>** As requested by City Council, Chief Tabak will discuss hybrid vehicle performance and vehicle graphics.

Ms. Howington introduced Chief Tabak, who provided information requested by Council. He explained that Hudson's new vehicle graphics meet and exceed standards for markings and visibility for police vehicles. To offset the darker cruisers, smart lighting has been added to the light bars to improve officer and motorist safety, both day and night. Additional lighting has been added to the sides of the vehicle, so that it can easily be seen from all angles of approach. He noted that additional reflective lettering and striping is being added to the vehicles, but it has been delayed by COVID-19. It will be completed soon. The new cruisers also include smart lighting which is computer-based and accounts for the speed of cruiser and adjusts to improve visibility.

Chief Tabak said that the Police Department now has five months of data on its use of hybrid police cruisers. Initial data showed a savings in gasoline costs, as well as reduced CO2 emissions. For the additional cost of each hybrid vehicle, he anticipated the City will break even at approximately 50,000 miles. Police vehicles usually are kept for 100,000 miles.

## AN ORDINANCE PLACING A MORATORIUM ON THE OPERATION OF ANY SHORT TERM RESIDENTIAL REAL ESTATE RENTALS IN THE CITY OF HUDSON; AND DECLARING AN EMERGENCY.

**Brief Description:** This Ordinance establishes a 180-day temporary moratorium prohibiting the operation of short term (less than 30 days) residential real estate rentals ("STRs") within the City of Hudson. The period of the moratorium will permit the City to conduct community outreach, study, formulate, and draft regulations with respect to STRs.
