#### **Special Meeting**

#### 1. Call to Order

Mayor Basil called to order the Special meeting of Hudson City Council at 7:15 p.m., in accordance with the Sunshine Laws of the State of Ohio, O.R.C. Section 121.22.

#### 5. Public Comments

Leslie Janikis, 869 Barlow Road, stated that he agrees with the concept of connectivity in the City, however he did not like the 8 foot pathway that is planned to be installed as part of the Veteran's Trail Phase 4 project. He did not feel that an 8 foot wide path is appropriate in a neighborhood, and such a path would be better suited in a park. He preferred a 5 foot concrete sidewalk be installed in front of his property or a path on the south side of the street, where there is more vacant land. He was hopeful for an alternate solution.

David Ion, 760 Barlow Road, stated that he lives on the south side of the Barlow Road within the limits of the Veteran's Trail, Phase 4 project and did not want the sidewalk/path on his property.

#### 6. Correspondence and Council Comments

Ms. Radigan stated that she was not supportive of a Special Meeting on November 12, 2019, as noted on the 60-Day View Report. Mayor Basil, Mr. Wooldredge and Dr. Williams also spoke in opposition of this Special Meeting. Ms. Radigan further stated that she has heard from some residents regarding creating quiet zones for the railroad crossing at Stow Road and Hines Hill Road, and she asked staff to look into this. Mayor Basil and Mr. Hanink also agreed that quiet zones should be looked into.

Mr. Wooldredge reminded citizens that current vacancies exist on the Environmental Awareness Committee, with applications due on November 1, 2019, as well as Planning Commission and Community Television Advisory Committee, with applications due on November 29, 2019; and the City is also accepting applications, pursuant to the Charter of the City of Hudson, Section 13.02, for the Charter Review Commission, with applications due on November 29, 2019.

Dr. Williams provided an update on the recent Hudson Community Television Advisory Committee meeting, and he stated that members thanked Council for their support of Hudson Community Television.

Ms. Bigham thanked those who attended the Ward forum last night.

#### 7. Report of Manager

Ms. Howington stated that the City offices, as well as the Public Works Support staff, have moved into the new City Hall space at 1140 Terex Road. She further explained the purpose of the 60-Day View Report and explained that the Special Meeting of November 12, 2019, was included to provide an option of obtaining a second reading for the budget. She also noted that the 60-Day View Report will be posted on the City's website for all residents to see.

#### A. 19-0110 City of Hudson 2020 - 2024 Five-Year Plan Review and 2020 Budget

**Brief Description:** This is the final scheduled meeting to review the City's 2020-2024 Five-Year Plan and 2020 budget. This meeting will focus on the Accelerated Road Program and the Broadband Fund.

Mr. Kosco provided an explanation on the 3 different options for the Accelerated Road Program. Staff recommended Option 1, which includes a 10-year, \$2.3 million bond that would be used towards the overlay of all concrete streets over a 2-year time frame, and an annual road program budget of \$2.7 million per year, which includes an increase of approximately \$500,000 from the Gas Tax increase, that would be used towards major roads and local roadways. All major roadways would be completed by 2024 and the Pavement Condition Index would increase from a 71 to a 78. Discussion followed regarding the various options and the process on the determination of how the paving list is compiled. There was consensus to move forward with Option 1.

Mr. Griffith provided an explanation on the Velocity Broadband 5-year budget. Council asked staff to provide quarterly financial updates on Velocity Broadband, beginning in January 2020.

This matter was discussed.

### B. 19-0111 Discussion Regarding Veteran's Trail Phase 4 - Barlow Road Sidewalk Project

**<u>Brief Description:</u>** Staff would like to update Council and gather input on the design of the Veteran's Trail Phase 4/ Barlow Road Sidewalk Improvement design after collecting comments from the September 26, 2019 Public Meeting.
