

**A RESOLUTION DESIGNATING MARGARET TUSSEY AS THE ALTERNATE DELEGATE TO THE REGIONAL COUNCIL OF GOVERNMENTS THAT ADMINISTERS THE REGIONAL INCOME TAX AGENCY; AND DECLARING AN EMERGENCY.**

WHEREAS, Resolution 80-29 established participation of the Village (now City) of Hudson in the Regional Council of Governments (RCOG) that administers the Regional Income Tax Agency (RITA); and

WHEREAS, the related agreement for participation allows each member to appoint a delegate to and one alternate to the RCOG; and

WHEREAS, currently, Jeff Knoblauch, Assistant City Manager/Finance Director, serves as the delegate and Brian Griffith, Assistant City Manager (former Assistant Finance Director) as the alternate; and

WHEREAS, historically, the Assistant Finance Director has served as the alternate, and with the recent promotion of Margaret Tussey to Assistant Finance Director, the City administration is recommending that Ms. Tussey be appointed as the Alternate Delegate.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Hudson, Summit County, Ohio, that:

Section 1. Margaret Tussey is hereby designated as the City's Alternate Delegate to the Regional Council of Governments that administers the Regional Income Tax Agency (RITA), to serve in that capacity in accordance with the rules and bylaws of the Council. Ms. Tussey replaces the City's former Delegate Brian Griffith.

Section 2. The Clerk of Council is hereby authorized and directed to notify RITA of this appointment and take such further action as maybe be necessary to implement this Resolution.

Section 3. That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

Section 4. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 5. This Resolution is declared to be an emergency measure necessary for the immediate preservation of life, property, the public peace, health, safety, and general welfare of City residents and for the further reason that it is immediately necessary to enable Ms. Tussey to attend the upcoming annual Regional Council of Governments meeting on June 17, 2025 whereas the City's Delegate is unable to attend; wherefore, this Resolution shall be in effect immediately upon its passage provided it receives the affirmative vote of five members of Council, except that six affirmative votes shall be required if all members are present; otherwise, it shall be in full force and effect from and after the earliest period allowed by law.
