#### 1. Call to Order

Mayor Shubert called to order the meeting of Hudson City Council at 6:31 p.m., in accordance with the Sunshine Laws of the State of Ohio, O.R.C. Section 121.22.

#### 2. Executive Session

A motion was made by Mr. Wooldredge, seconded by Mr. Foster, to enter into executive session to consider a personnel matter concerning the appointment of public officials and to interview applicants for the City's Park Board and Tree Commission. The motion carried by an unanimous vote.

*At 7:15 p.m., Mayor Shubert recessed the meeting, and Mrs. Bigham entered the meeting.*

*Mayor Shubert resumed the regular meeting at 7:30 p.m.*

**Brief Description:** Consideration of proposed Land Development Code Text Amendment to amend the City's Land Development Code, Section 1205.10, District 7: Outer Village Commercial Corridor and Office Overlay Zone, and Section 1206.01, Table of Permitted and Conditional Uses by Zone District, to permit single family attached dwellings, townhomes, and planned developments as allowed uses within the District 7 Office Overlay.

*Mayor Shubert opened the public hearing for Ordinance No. 21-54 at 7:31 p.m.*

*Mr. Sugar provided a brief introduction and overview of the applicant's request for a development approval pertaining to a Zoning Code text amendment. He noted that there is a separate ongoing application for a different townhome development off of Barlow Road, which is scheduled for review by the Planning Commission on June 14, 2021.*

*Testimony was provided by the development team, including the applicant, Mr. David Mitchell, who provided a presentation (attached to record copy of these minutes) and Mr. Jason Rice, who reviewed the proposed site plan for twelve 4-unit buildings to feature luxury townhomes focused on attracting empty nesters. Mr. Mitchell also explained the changes made pursuant to the Planning Commission's review, he addressed the traffic study, and he asked Council to apply established guidelines and community objectives for diversified housing stock. He said the subject property is zoned in both Districts 3 and 7, and he asked that the rear property uses be permitted on the property fronting Darrow Road. Ms. Julie Sabroff said that there is an abundance of existing office space available and no interest in building a commercial building at this site. With few available housing options for empty nesters, she urged Council to allow residential development on the two front properties, which currently can only be developed commercially. The proposed changes were forwarded to City Council from Planning Commission.*

*The following public testimony was heard:*

- Mrs. Chrissanna Krisch, 5971 Eastham Way, spoke in opposition to the proposed text amendment, stating that the proposed change would increase traffic, change the character of this area, and negatively impact the existing homes in Plymouth Village and Old Town Colony (see statement attached record copy of these minutes).*
- Ms. Karyl Morrison, 346 Simon Road, spoke in favor of the proposed text amendment, which she said would allow more housing options for people wishing to downsize and stay in Hudson. She said that this project will offer maintenance-free living for people not ready for senior living.*
- Mrs. Sarah Norman, 2212 Edgeview Drive, spoke in opposition to the proposed text amendment. She said that the current Land Development Code and Comprehensive Plan are hostile to individual home builders and very accommodating to anyone wishing to engage in large-scale development. She said the proposed amendment would allow development that is different than the plans presented, and she asked Council to reject the proposed amendment until they can guarantee the outcome of the proposed development.*
- Mr. Steve Krotosky (developer, former resident, and Hudson property owner) said that he moved from Hudson, because he couldn't find a smaller home. He said that the proposed amendment would allow*

*opportunities for people to downsize and have good quality housing and a maintenance-free lifestyle.*

*Mayor Shubert opened the floor to Council comments. Responding to Mr. Sutton's question, Mr. Vazzana confirmed that the Ordinance would be subject to the new density clause of the City's Charter. Discussion followed concerning maximum density.*

*Mayor Shubert closed the public hearing for Ordinance No. 21-54 at 8:25 p.m.*

## **7. Public Comments**

*Ms. Lisa Radigan, 84 Stratford Road, referring to her letter read at the June 16, 2020, Council meeting, she stated that Hudson is not immune to the racism that permeates our society. She supported Council's subsequent passage of Resolution No. 20-76 to condemn racism and promote fair and equal treatment for all and for the City's funding of police body cameras. She encouraged support of diversity, equity, and inclusion initiatives, and she encouraged opportunities to for community members to engage in discussion. She expressed opposition to Mrs. Bigham's recent social media comments concerning an incident involving high school students and racial hate speech.*

*Mrs. Julie Ann Hancsak, 60 Division Street, expressed appreciation for the City's work to convert the former Hudson Elementary School to establish the neighborhood park at the corner of Oviatt and Division Streets. In addition, she thanked Council for passage of Resolution No. 20-76 (above) and its implementation, and she encouraged Council to determine what further actions are needed. She also expressed opposition to Mrs. Bigham's social media comments.*

*Mrs. Amanda Weinstein, 8 North Westhaven Drive, said that Resolutions and platitudes against racism are not enough. She expressed opposition to other social media comments from Mrs. Bigham's relating to anti-Semitic death threats and racial slurs received by the Weinstein family. She encouraged creation of a task force or committee to review the systems, institutions, regulations, and processes that may be contributing to racial inequalities and injustices in our community.*

*Mr. Christopher Macchione, 1449 Winchell Drive, spoke of his upbringing in Hudson and the positive influence of school staff and caring community members. He encouraged the community to take pride in Hudson's history to confront racism, and he asked that people consider opportunities to engage in discussions with people of different backgrounds.*

*At Mr. Wooldredge's request, Mrs. Slagle later read an email he had received from Mr. Don Reed, 1542 Groton Drive, concerning the recent display of racism at by high school students and Mrs. Bigham's related social media posts. He supported the Diversity Equity and Inclusion Program and encouraged all Council members to rid our community of overt racism (email attached to record copy of these minutes).*

## 8. Correspondence and Council Comments

*Mrs. Bigham addressed concerns expressed during public comments. She confirmed her belief in diversity, equality, and inclusion. Referring to the racist event involving high school students, she explained her position and said her social media comments were intended to advocate for the minor students. She encouraged a more positive atmosphere, rather than negativity, division and hate.*

*Mrs. Kowalski wished a speedy recovery to Mr. Brian Wilch, Hudson High School Principal. She also wished a happy Pride Month to the community. She expressed her support for the community's diversity, equity, and inclusion efforts, and she encouraged everyone to work harder to make Hudson a more equitable place. Finally, she read a letter from Dr. Joseph Ortiz, 5303 Wilshire Park Drive, who shared his dismay concerning the recent racist and homophobic events involving high school students and expressed his support to implement DEI in the School District's curriculum (see letter attached to record copy of these minutes).*

*Ms. Schlademan read the following correspondence into the record: 1.) email from Mr. and Mrs. David Thiele, 48 Aurora Street, supporting the School District's DEI efforts and urging Council to support diversity, equity, and inclusivity as basic tenets of decency, democracy, and ethical responsibility; and 2.) letter from Andrea Bucey Tikkanen, 1480 Groton Drive (signed by 16 other residents) urged the City's leaders as role models to increase their commitment to DEI efforts. Ms. Schlademan stated that national and community events are deeply troubling to her, and she encouraged Council and the community to double-down on the commitment to DEI efforts through intentional dialogue within the community. She encouraged Council to support the School District, community organizations and residents in this regard.*

*Mr. DeSaussure congratulated Hudson resident Jason Kokrak for winning the Charles Schwab PGA Tournament. Regarding the subject of racism, he said that too often discussions result in name-calling. He said that it's easy to take things out of context on social media, and he advocated for not bringing social media into Council. He encouraged this Council to refrain from name-calling and to be open to good faith participation and careful when engaging in political discussions.*

*Mr. Sutton updated Council regarding the Railroad Crossing Quiet Zone Project, noting that the private crossing owner is not interested in participating at this time, so the only locations will be at the crossings on Stow Road and Hines Hill Road. He reminded those interested that he will host a Ward 3 Open Forum at Hudson Springs Park on June 7th.*

*Mr. Wooldredge encouraged people in these difficult times to listen to each other and seek to understand each other. He said that people are not changed by government, but each individual can change from within.*

*Mayor Shubert urged everyone to respect one another and treat others with decency, kindness, and civility, and we will all get along much better.*

*Mr. Foster shared his frustration with the tendency for people in this country to throw stones at each other, which ends dialogue. He encouraged people to have open discussions, listen to others' perspectives, strive to understand, and stop the angry dialogue.*

*Mrs. Bigham congratulated the Hudson High School Class of 2021, who endured significant challenges.*
