

**A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A PROFESSIONAL SERVICES CONTRACT WITH PAVEMENT MANAGEMENT GROUP FOR 2025 PAVEMENT ROAD RATINGS.**

WHEREAS, the City of Hudson attempts to rate its public asphalt streets every two years and utilizes the Ohio Department of Transportation Pavement Condition Index (PCI) System to do so; and,

WHEREAS, road assessment data is collected via high-definition videos and summarized in a report and map system that is used to help develop the annual asphalt resurfacing programs; and,

WHEREAS, the City received two quotes for road assessment services, detailed as follows:

1. Pavement Management Group (PMG): \$27,500.00;
2. Vialytics: \$23,792/year with a required 3-year contract totaling \$71,376.00; and,

WHEREAS, the City has been working with Pavement Management Group (PMG) since 2014, and the company conducts thorough evaluations of asphalt road surfaces, analyzing pavement issues such as cracks, potholes, rutting, and surface deterioration; and,

WHEREAS, after going through the necessary steps for the selection of this professional services vendor, the City administration is recommending that the City continue to utilize Pavement Management Group (PMG); and

WHEREAS, it is in the best interests of the City of Hudson and its residents that this contract be entered and that these services be completed.

NOW, THEREFORE, BE IT RESOLVED by the Council of Hudson, Summit County, Ohio, that:

Section 1. The City Manager and his designee are authorized to enter into an agreement with the Pavement Management Group for the City's 2025 Pavement Road Ratings. The agreement shall be in a form satisfactory to the City Solicitor.

Section 2. The City Manager and his designee are authorized to do all things necessary to enter into and implement a contract with Pavement Management Group (PMG) in an amount not to exceed \$27,500.00 for the City's 2025 Pavement Road Ratings.

Section 3. That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

Section 4. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 5. This Resolution shall take effect and be in force from and after the earliest period allowed by law.
