1. Call to Order

In the absence of Mayor Shubert, President of Council Wooldredge called to order the meeting of Hudson City Council at 7:30 p.m., in accordance with the Sunshine Laws of the State of Ohio, O.R.C. Section 121.22.

5. Public Comments

Mrs. Carol O'Connell, President of the League of Women Voters Hudson read a statement, clarifying the League's position regarding term limits, and she questioned the revised version of Ordinance No. 21-65 (see statement attached to record copy of these minutes).

Mrs. Gerry Kenney, 6884 Stow Road, shared her experiences with youth ministries and spoke about the need to make sure that destructive issues facing our world and community do not divide us and our children (statement attached to record copy of these minutes).

The following residents spoke in support of Resolution No. 21-75 for providing funding to the Hudson DEI Alliance.

- Mr. Peter Wiley, 168 Hudson Street, encouraged support of this Resolution in order to facilitate community-wide engagement, and he spoke of safety and economic development implications.
- Ms. Lisa Radigan, 84 Stratford Road, said that support for this grass-roots initiative and efforts to be more welcoming is important.
- Ms. Kristen Callihan, (address unknown) local business owner and mother, encouraged support and said that adults need to exhibit good behavior as an example to children.
- Joan Sauer, 47 Hudson Commons Drive, encouraged support in an effort to reach long-term solutions to discrimination.
- Mrs. Amanda Weinstein, 8 North Westhaven Drive, spoke out against racially charged events that have occurred in the community and said that there is economic value in creating a social infrastructure.
- Mrs. Laura Alvarez, 7843 Alexandra Drive, spoke of the need to create a welcoming community and embrace diversity, equity and inclusion, so that kids will grow in a global community.
- Ilene Kennedy, 166 Aurora Street, said that dialog is important, different points of view are opportunities for learning, and the benefits to be gained have many applications.
- Dr. Patricia Goetz, 16 College Street, urged support for funding this initiative to begin addressing problems this community is facing.

The following residents spoke in opposition to Ordinance No. 21-65 for submitting to the electors a proposal to change the Charter to include term limits for Council members and the Mayor.

- Mrs. Kathy Gerrard, 2370 Danbury Lane, expressed concern regarding a high turnover (statement attached to record copy of these minutes).
- Mrs. Karin Swedenborg, 94 Aurora Street, said that this Ordinance is a solution to a problem that does not exist (statement attached to record copy of these minutes).
- Mr. William Carroll, 69 College Street, opposed term limits and the attempt to radically change the City's government (statement attached to record copy of these minutes).

Mrs. Barb Earnhardt, 975 Westhaven Drive, said that she has not witnessed racism in Hudson, she questioned the proposed actions being contemplated through DEI Alliance, and she spoke of the many community groups and organizations that are self-funded and urged Council to oppose Resolution No. 21-75 for DEI Alliance funding by the City (statement attached to record copy of these minutes).

6. Correspondence and Council Comments

Mr. Foster read a letter from Mrs. Katie Rundell, 5383 Wilshire Park Drive, in support of Resolution No. 21-75 and City funding for Hudson DEI Alliance (see statement attached to record copy of these minutes).

Mrs. Kowalski reminded citizens that even if you have had the COVID-19 vaccine, it is still possible to come down with COVID-19, so it's important to stay diligent.

Mr. Sutton thanked employees for their efforts in making the fireworks event a success. He provided an update concerning the recent Tree Commission meeting. With an understanding that the Ohio Department of Natural Resources does not classify the Cottonwood Tree as a nuisance species, the Commission will be recommending that Council take no action on a recent resident proposal to do so. Other topics discussed included Main Street trees, Green on the Green event, and community outreach to engage with citizens. He asked that staff review a traffic situation at State Route 303 and Route 8.

Mr. DeSaussure thanked everyone who provided comments this evening. He supported the Tree Commission's recommendation regarding Cottonwood Trees.

Mrs. Bigham thanked the City employees and staff for their efforts in support of the fireworks event to make sure traffic was being directed and for keeping everyone safe.

Ms. Schlademan also thanked the volunteers who helped clean up after the fireworks event. She announced that the Environmental Awareness Committee will meet tomorrow in-person at Town Hall. She spoke of the need to revisit short-term rental property regulations and said that she will provide additional details regarding the proposed DEI funding for discussion at the next Council workshop.

7. Report of Manager

Ms. Howington reported on the following:

- Thanked City staff for their hard work before, during, and after the 2021 Independence Day Fireworks Celebration.
- Reminded citizens that all upcoming special events in Hudson can be found on the new special events calendar on the City's website.
- Celebrate Hudson events are planned during the Labor Day weekend, including a parade, music, a community art show, and more. Details are available via the City's website. Celebrate Hudson weekend events, music, art, and parade. commented that the State legislature did not extend the deadline for virtual meetings, all must be in-person. Public comments in-person or submit correspondence to Council members.
- The State Legislature is no longer allowing virtual public meetings. All Hudson Boards, Commissions, and Council meetings must now be held in person. Public comment is also required to be given in person, or via letter sent to a Hudson City Council member to be read into the record.

8. Appointments

Mr. Wooldredge recognized Mr. David Faiman for four years of service on the Tree Commission and Mr. Sean McGurr for three years of service on the Park Board.

10. Legislation

A. <u>21-65</u>

AN ORDINANCE SUBMITTING TO THE ELECTORS OF HUDSON A PROPOSAL BY HUDSON CITY COUNCIL TO AMEND SECTIONS 3.01 AND 4.01 OF THE CHARTER OF HUDSON CONCERNING TERM LIMITS FOR MEMBERS OF CITY COUNCIL AND THE MAYOR.

Brief Description: Councilman Foster has proposed amendments to the City's Charter to implement term limits for members of City Council and the Mayor. Pursuant to Charter Section 13.01, five or more affirmative Council votes are necessary for passage of this Ordinance.

Mr. Foster opened discussion, saying that term limits is an issue that has been considered for years, and while he understood the concerns raised, he thinks that the broader community supports term limits, and passage of Resolution No. 21-65 gives voters the ability to weigh in on the issue. Discussion followed with each Council member expressing their position and rationale.
