A RESOLUTION PURSUANT TO OHIO REVISED CODE 5521.01 CONSENTING TO THE DIRECTOR OF THE OHIO DEPARTMENT OF TRANSPORTATION TO COMPLETE A NOISEWALL PROJECT (PID NO. 98622) WITHIN THE CITY OF HUDSON, AUTHORIZING THE CITY OF HUDSON TO SERVE AS THE LOCAL PUBLIC AGENCY, AUTHORIZING FUNDS THEREFOR, AND DECLARING AN EMERGENCY.

WHEREAS, the State of Ohio has identified the need for the described project: CUY IR 0080 Noisewalls (along Ohio Turnpike at or near Jessie Drive in the City of Hudson) (the "Project"); and

WHEREAS, this Council desires to participate as the Local Public Agency ("LPA") in this Project.

NOW, THEREFORE, BE IT RESOLVED by the Council of Hudson, Summit County, State of Ohio, that:

<u>Section 1</u>: <u>Consent Statement</u>. Being in the public interest, the LPA gives consent to the Director of Transportation to complete the above described Project.

<u>Section 2</u>: <u>Cooperation Statement</u>. The LPA shall cooperate with the Director of Transportation in the above described Project as follows:

The LPA agrees to participate by providing a lump sum amount for the Project not to exceed One Hundred Forty-Five Thousand Dollars (\$145,000.00).

<u>Section 3</u>: <u>Authority to Sign</u>. The City Manager of the City of Hudson is empowered on behalf of the City of Hudson to enter into contracts with the Director of Transportation necessary to complete the above-described Project within the funding limit authorized in Section 2 above.

Section 4: This Resolution is declared to be an emergency measure necessary for the preservation of the public health, safety and general welfare and for the further reason that ODOT is requiring the immediate adoption of this legislation and the City's agreement to participate in the Project in order for the Project to proceed as scheduled; wherefore, this Resolution shall be in full force and effect immediately upon its passage, provided it receives the affirmative vote of five members of Council elected thereto or six affirmative votes if all members of Council are present at the meeting at which it is passed; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
