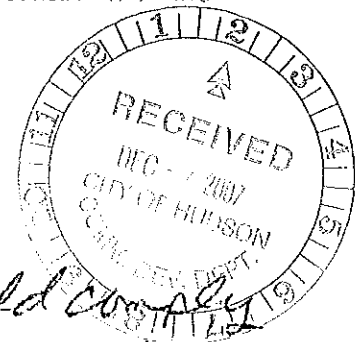

TO CREATE CONTINUITY OF SIGN DESIGN AND COLOR FOR:

1. BUILDING LOCATION: 85 S. Main Street, Hudson, Ohio
2. OWNER: The Cambridge Company, 220 N. Main Street, Hudson, OH 44236
3. Hereafter all signs on the facia board of the building to be no greater than 3/4" thick by 10" high x 16' long with a 1/2" beveled edge i.e. Great Lakes Baking Company on west side.
4. Background color on signs to be hunter green in matte finish with off white boarder and letters.
5. Size of lettering to be in proportion to the size of the overall sign.
6. Signs to be secured to the building with screws.
7. Soft lighting for signs to be optional for any given tenant.
8. Signs secured to the brick building can not be greater than the existing Starbuck sign on the south side of the building.
9. The Cambridge Company, at their expense, will redo the Great Lakes Baking Company signs on the north and west side of the building to conform with the above sign design and color.
