

**A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A PROFESSIONAL SERVICES CONTRACT WITH EUTHENICS INC. FOR THE DESIGN OF THE SR 303 SAFETY IMPROVEMENTS PROJECT (PID 117269).**

WHEREAS, in January 2022 the Ohio Department of Transportation finalized the Formal Safety Study of the roadway and pedestrian corridor along W. Streetsboro Street (SR 303) between Boston Mills Road and SR 91; and

WHEREAS, the resulting recommendation for construction of improvements addressing pedestrian and bicycle safety included roadway redesign, consolidation of driveways, upgrades of curb ramps and timers and removal of sight obstructions; and

WHEREAS, in May 2022, ODOT awarded the City a safety grant for \$278,000 to be used toward the design of the project that was estimated to total \$323,000 of which \$53,900 was estimated for the design portion; and

WHEREAS, In February 2023, the City sent out the RFP to seven (7) ODOT qualified civil engineering consulting firms to solicit proposals from professional design, engineering and surveying consultants (Consultant) for the and design of the project; and

WHEREAS, the City received one (1) formal proposal for the project from Euthenics, Inc that exceeded the ODOT estimate; and

WHEREAS, the City reduced the cost by performing some of the design work in-house and further obtained additional funding of \$52,000 from the State; and

WHEREAS, Euthenics, Inc is a professional design, engineering and surveying firm and pursuant to Charter Section 6.04, Council may authorize contracts without advertising for bids for professional services; and

WHEREAS, staff estimates the cost of the project at \$127,724.77, plus a 5% contingency of \$6,386.24 for a total of \$134,111.01; and

WHEREAS, the amount budgeted is \$75,000 and requires a supplemental appropriation of \$59,111.01.

NOW, THEREFORE, BE IT RESOLVED by the Council of Hudson, Summit County, State of Ohio, that:

Section 1. The City Manager is authorized enter into a consulting agreement with Euthenics, Inc for design of the State Route 303 Safety Improvement Project (PID 11729) as

described in the formal Request for Proposals in an amount not to exceed One Hundred Thirty-Four Thousand One Hundred Eleven dollars and One cent (\$134,111.01), staff's estimate with an additional 5% contingency.

Section 2. That the above recitals are fully incorporated as findings herein.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4. This Resolution shall take effect and be in force from and after the earliest period allowed by law.
