6. Proclamations

A. 18-0104 Recognition of Bells of Peace, A National World War I Remembrance - November 11, 2018.

Executive Summary: This Proclamation will commemorate the tolling of bells across the United States, which will occur at 11 a.m. on Veterans Day, November 11, 2018, in honor of those who served in the Great War.

Mr. Christopher Bach accepted the Proclamation on behalf of the Hudson WWI Memorial Restoration and Centennial Committee. He spoke of the importance of Veterans Day and shared stories of celebrations that took place in Hudson on Armistice Day on November 11, 1918. He invited all to gather for a ceremony to be held on the southwest Green on Sunday, November 11, 2018, at 11:00 a.m. to commemorate the 100th anniversary of the armistice that ended the fighting in World War I and to pay tribute to Hudson residents who served.

Mayor Basil read this Proclamation in its entirety, recognizing Bells of Peace.

B. <u>18-0105</u> Special Recognition of America Recycles Day - November 15, 2018

Executive Summary: Mayor Basil will proclaim Thursday, November 15, 2018, "America Recycles Day" in Hudson, recognizing Hudson's effort to increase the nation's recycling rate. Jeffrey Wells, Chairman of Environmental Awareness Committee (or designee) and Sonya Mottram, Administrative Support Supervisor, will be in attendance to accept this Proclamation.

Mrs. Mottram accepted this Proclamation on behalf of the Environmental Awareness Committee, and she spoke of the Committee's dedication to recycling and education.

Mayor Basil read this Proclamation in its entirety, recognizing America Recycles Day.

7. Public Comments

Mrs. Beth Innamorato, 27 Steepleview Drive, submitted a proposed conceptual plan for the Downtown Phase II development (attached to record copy of these minutes). She suggested traffic calming, a buffer area for Owen Brown Street, and areas for residential, commercial and green spaces. She urged City Council to consider her plan and to place a ballot issue before voters regarding Downtown Phase II.

Mr. Jim Garrison, resident of 840 Ashbrooke Way and American Legion Post 464 Adjutant, spoke of Hudson's eighty-one WWI veterans, the names of whom are on a restored bronze memorial tablet. He shared the names of local WWI veterans who founded the local American Legion Post, one of whom was Webb Greenlese, who is buried in an unmarked grave in Markillie Cemetery. He said the Legion is in the process of locating the grave and getting a suitable marker. He noted that some of the charter members of the American Legion were responsible for placing the tablet on the Clocktower in 1919. He said that the restored memorial tablet will be affixed to a new stone pedestal base and presented at a rededication ceremony following the parade on Memorial Day 2019.

Mrs. Heidi Schweighoefer, resident of 7449 Hudson Park Drive and President of EMS Outreach Hudson, spoke of the organization's mission and its contributions and donations to the community, including the recently established RUOK Program that links at-risk seniors with trained volunteers. She said that there are many local senior citizens in need, and she urged City Council to support Ordinance No. 18-147 to establish a Senior Citizen Advisory Committee.

Marilyn Olzmann, 549 Atterbury Blvd., spoke on behalf of Rejoice Lutheran Church in favor of establishing a Senior Citizen Advisory Committee in Hudson.

Mr. Greg Janik, 36 Thirty Acres, thanked previous speakers for comments concerning a Senior Citizen Advisory Committee. He also thanked elected officials and staff for being receptive to decreasing chemical applications to the City's public Greens, and he urged the City to eliminate chemical applications altogether in the future. Then he spoke as the City's former Co-Chair of the Ad Hoc Deer Committee and on behalf of fellow residents, David and Dawn Burke, Valerie Strong, and Tara Prior, in opposition to the City's Deer Hunting Program. Finally, he spoke as the City's former Co-Chair of the Ad Hoc Recycling Committee, he urged that the City consider incorporating a downtown recycling center into Downtown Phase II.

8. Correspondence and Council Comments

Mr. Wooldredge acknowledged public comments in support of establishing a Senior Citizen Advisory Committee.

On this Election Day, Mr. Kelemen noted the appropriateness that the day falls close to Veterans Day, as a reminder of the sacrifices made for our right to vote. He shared that, as a poll worker, he expected electors to be happy and grateful for having that right to express themselves, but he was disappointed to witness many who were angry. He encouraged improved civility at all levels of government. Mayor Basil agreed and shared his father's involvement in World Ward II.

Mr. DeSaussure applauded local citizen efforts to keep the memory fresh of local veterans who served in World War I. In addition, he said that he was on Council when the Bow Hunting Program was implemented. He said that the program was deemed necessary after much deliberation and public input, due to a significant increase

in car/deer accidents. He said that the deer population was considered a public safety hazard, and the program has proved to effectively reduced the number of such accidents. He supported the City's Bow Hunting Program.

Mr. Wooldredge said that he was also on Council when the Bow Hunting Program was established. He supported the program and agreed that it has greatly reduced deer accidents, as well as providing meat. In addition, he shared his father's involvement in World War I.

Dr. Williams said that he was also on Council when the Bow Hunting Program was established. He felt the program to be successful, safe and humane, and he supported its continuance.

Mr. Hanink shared that the Cleveland Zoo was established about 100 years ago in order to exhibit white tail deer, which at the time had been eradicated from Ohio. He said that any serious environmentalist understands that there is a balance in nature; and being that there are no predators in northeast Ohio, without control, deer will ruin the understory and the ability of forests to regenerate. While he said the City's program was small in scale, data is available for citizens to review the dramatic improvements since implementation. He supported the program as a member of Council when it was established, and he encouraged its continuance.

Mayor Basil noted that he also was on Council at the time the Bow Hunting Program was implemented, and he agreed that overpopulation of deer can wreak ecological havok on the forest. He noted that at the time, City officials had also considered professional sharp-shooters as an option in reducing the deer population.

9. Report of Manager

Ms. Howington encouraged Council support for accepting the recommendation not to implement the City's Growth Management Residential Development Allocation System during 2019 (Resolution No. 18-142), clarifying that the Growth Management System remains an active element in the City's Land Development Code, which will not change with passage of this legislation.

She reminded people to shop locally and remember North Main Street merchants, regardless of the current construction project.

She announced that the City has received an award for a clean audit, and she congratulated the Finance Dept. and Mr. Knoblauch for managing the City's finances so well.

Finally, she reported that the City has obtained a better renewal rate from Medical Mutual of Ohio for the employee's health insurance, realizing a 1.18 % decrease from the 2018 rates, a savings of \$145,000 for the City and providing a reduction in employee premiums to employees. She recognized Mrs. Havranek and Mr. Griffith for their hard work in stewarding tax-payer dollars. Mayor Basil said that these extraordinary efforts speak very well for staff, as well as the City Manager's leadership.

10. Discussion Item

A. 18-147

AN ORDINANCE ENACTING A NEW CHAPTER 296 OF THE ADMINISTRATIVE CODE CREATING A SENIOR CITIZEN ADVISORY COMMITTEE OF HUDSON AND PROVIDING POWERS AND DUTIES THEREFORE.

Executive Summary: This Ordinance will establish a Senior Citizen Advisory Committee for the purpose of advising Council on needs and issues affecting senior citizens and for the purpose of providing education and information to enhance the quality of life in the community.

Mayor Basil spoke in support of Ordinance No. 18-147, noting that Hudson is a graying community with senior citizen issues, and Senior Citizen Advisory Committee would benefit a growing portion of our community in a proactive effort, utilizing talents of volunteer residents in an advisory role to Council. He encouraged Council discussion, consideration, and support.

Discussion followed. Mr. Wooldredge spoke in support of this Ordinance, considering it a first step that will lead to ideas on how the community can serve the senior citizen population. Dr. Williams also supported this Ordinance, considering it long overdue. Mr. Hanink said that we are living in a community that has volunteers as a bedrock; and being mindful of Council's role as stewards, he said that Council must determine which services are essential and if senior services would be better provided by government versus developing the private energies of independent citizens and building on volunteer efforts to serve the senior citizen population. Mr. Kelemen acknowledged Hudson's senior population, but he preferred this matter be discussed at a workshop and that action be postponed, so that Council can take a more deliberative approach, possibly establishing an ad hoc committee initially. Mr. DeSaussure questioned the need to establish such a committee for the senior demographic, noting that Council continually strives to be responsive to all citizens. He supported utilizing a portion of the new City Hall for senior activities. Mayor Basil spoke of the unique needs of the senior population and noted opportunities for the City to collaborate in helping. Mr. Wooldredge said that many cities provide services to seniors. Mr. DeSaussure noted that there is no age requirement for committee members.

11. Appointments

Mr. Wooldredge stated that the City is accepting applications through November 16th for openings on the Cemetery Board, Environmental Awareness Committee, Board of Zoning & Building Appeals, Planning Commission, HCTV Advisory Committee, and Tree Commission.
