RE: November 2012 Financial Report

Attached are the November month end financial reports. The reports include the following:

1. A Statement of Cash from Revenue and Expense
2. An Executive Summary of the City's major funds: including the General Fund, Street M&R (Service), Cemetery, Parks, Cable TV, Fire, Emergency Medical Services, Water, Wastewater, Electric, Storm Water, Golf Course and Fleet Maintenance Funds. This report shows variance ratios of year-to-date revenues and expenditures compared to previous year-to-date and current budget figures.
3. Bank Report has been included to summarize the investment instruments on which the City earns interest income.
4. Variance Notes have been included to highlight variations from budget projections listed on the Executive Summary.
5. Utility Billing Delinquency Report has been included to show the past due balance totals for our utility customers along with the balances that have been turned over to collections and certified to Summit County and placed as a lien on the property. Also included is the balances written off due to bankruptcy, collection company fees and smaller, immaterial amounts.
6. Bank Reconciliation has been included to show the City's accounts and related reconciling items.

VARIANCE NOTES FOR NOVEMBER 2012 FINANCIAL REPORT

REVENUE:

2011 Year-To-Date (YTD) vs. 2012 YTD Actual

Real and Personal Property Taxes are \$194,000 lower in 2012 primarily due to reduced real property tax valuation.

Income Tax revenues are \$165,000 lower in 2012 due to a large one-time payment from a major employer in 2011. We estimated the General Fund impact would be \$800,000. Excluding the one-time impact, income taxes are \$635,000 higher than budget for the General Fund.

Including Parks, Fire, EMS and Hudson Schools, total income taxes are down \$229,000 or 1.4%. Excluding the estimated impact of the large, one-time payment income tax revenue is up approximately 5.5%.

Local Government Funds are \$216,000 lower in 2012 due to cuts in state funding.

Estate Tax is \$125,000 lower in 2012 due to lower estate settlements. We have exceeded our budget for all of 2012 by \$913,000.

Interest Income is \$175,000 lower in 2012 due to the overall lower interest rates.

Transfers In, Advances and Reimb are \$2,316,226 higher in 2012 primarily due to \$2,250,000 advance returned to the General Fund from the Land Conservancy and Metro Parks grant proceeds for the YDC property.

Cable TV is \$104,000 higher in 2012 primarily due to a \$75,000 advance from the General Fund for camera equipment and \$26,000 increase in franchise fees.

Fire Department is \$82,000 lower in 2012 primarily due to \$71,000 in Fire Act grant revenue and \$19,000 in proceeds from the sale of vehicles received in 2011.

Water is \$303,000 higher in 2012 due to \$249,000 increased customer sales revenue from the rate increase and increased water investment fees.

Wastewater is \$281,000 higher in 2012 primarily due to \$232,000 increased customer sales revenue from the rate increase.

Storm Water is \$248,000 lower in 2012 due to decreased transfer from the General Fund vs. 2011.

Ellsworth Meadows is \$128,000 higher due to increased play in 2012 vs. 2011 as a result of the significantly improved weather this year.

EXPENDITURES:

2011 YTD Actual vs. 2012 YTD Actual

General Fund expenditures have decreased \$1,452,000 through November 2012 as compared to November 2011. The largest variances are as follows:

Police decreased \$109,000 primarily due to the timing the police pension payment (this will normalize by year end); **City Solicitor** increased \$39,000 due to increased legal fees from the increase in caseload. **Finance** increased \$78,000 due to severance pay and personnel in 2012; **Engineering** decreased \$40,000 due to reduced personnel costs and **Public Properties** decreased \$226,000 primarily due to decreased snow and ice removal cost and decreased YDC property expenditures. For the **YDC property**, we've spent \$180,000 on maintenance through November 2012 (we budgeted \$190,000 for the year). This includes \$73,000 in natural gas and \$54,000 in water. The high water bill covers all of 2011

and was due to multiple leaks in the line that have since been repaired. Our **Transfers and Advances** out decreased \$1,453,000 due to the \$2,250,000 advance from the General Fund in 2011 to pay down the YDC note in anticipation of the Land Conservancy and Metro Parks grant funding. This was offset by the advance to Cable TV, increased transfers to our Economic Development Fund and Street Construction Fund in 2012.

Street Maintenance & Repair expenditures are \$213,000 lower in 2012 primarily due to \$218,000 reduced road salt purchases and reduced contractual snow removal payments and overtime.

Cemeteries Fund expenditures are \$55,000 higher in 2012 primarily due to the \$20,000 return of an advance from the General Fund and increased personnel and overall operating costs.

Cable TV Fund expenditures are \$257,000 higher in 2012 primarily due to the \$204,000 purchase of replacement cameras and related equipment; \$5,000 advance back to the General Fund and \$36,000 internal wiring and new high school stadium projects.

EMS Fund expenditures are \$199,000 higher in 2012 due to \$129,000 spent on the roof replacement and \$32,000 for radio narrow banding equipment.

Water Fund expenditures are \$267,000 lower in 2012 primarily due to the timing of the debt payment posting. The payments were posted in November 2011 vs. December 2012. This will normalize by year end.

Electric expenditures are \$5,153,000 lower in 2012 primarily due to \$3,900,000 payoff of outstanding notes in 2011 and \$1,019,000 in payments on the College Street substation in 2011.

Fleet Fund expenditures are \$244,000 higher in 2012 due to payments for three Service Department trucks, an Electric Department aerial truck, snow plow chassis and packages and a tractor mower in 2012.

2012 YTD Actual vs. 2012 Budget

Revenues are within a reasonable variance range except as follows: **Estate tax** is \$912,000 higher than estimated due to conservative estimating and unpredictable nature of the revenue stream. **Interest Income** is \$44,000 below estimate due to continued reduced interest rates. **General Fund Transfers, Advances and Reimbursements** are \$62,000 higher than projected due to insurance reimbursements and advances in from the Cemetery and Cable Fund. **Miscellaneous** revenue is \$100,000 higher primarily due to the two year cell tower lease payments and auction sale proceeds. **Water** and **Electric** are higher due to increased customer sales presumably from increased sprinkling and air conditioning with the high temperatures over the summer along with the rate increases.

Expenditures are generally favorable or reasonably close to budget. **Police** is \$154,000 below budget primarily due to pension payment timing. The **Community Development** budget is \$80,000 below estimate due to vendor payments that have yet to be paid and vacancies within the department. **Street Maintenance and Repair** is \$145,000 over budget due to a change in personnel department chargeback subsequent to the preparation of the budget. This will need to be adjusted before year end. The **Parks Department** is \$326,000 below budget due to the Spine Trail budget being carried over into 2013. **Fire Department** is \$205,000 below budget mainly due to the hydrant projects and smaller capital purchases not yet being expensed. **Stormwater** is \$154,000 below budget due to timing on completion/payment of projects.
