Chief Robbins –

The 2013 City of Hudson Budget provides for the replacement of one marked police cruiser at a cost of \$30,000.

Based upon current mileage, age, and overall condition, I recommend replacing marked cruiser # 7 (2010 CVPI - Fleet ID 1158) with a 2013 Chevrolet Tahoe. The Ford Crown Victoria Police Interceptor was discontinued in 2011 and the department does not currently have a larger vehicle suitable for carrying extra passengers and/or equipment nor one with four-wheel-drive capability.

I requested quotations from the recipient of State Contract RS901213 (*Law Enforcement Vehicles – 2013 Model Year or Newer, effective through 10/31/2013*) Byers Chevrolet of Columbus, along with local dealers Montrose Auto Group and VanDevere Chevrolet for a 2013 Chevrolet Tahoe equipped consistently with the rest of our patrol fleet.

Of the three quotations received, Byers Chevrolet returned the lowest, at state contract pricing, at \$29,766. VanDevere Chevrolet quoted \$30,593.50 and Montrose Auto Group was at \$31,357.90 for the same vehicle.

I recommend to you and City Council that legislation be passed awarding Byers Chevrolet a \$29,766 contract to provide our replacement police vehicle this year.

Chevrolet has established an order deadline of April 4<sup>th</sup> 2013 for the 2013 Tahoe and Byers Chevrolet may not be able to provide a 2014 model at the same price after this cut-off date.
