A RESOLUTION AUTHORIZING THE INTERIM CITY MANAGER TO ENTER INTO A PURCHASE AGREEMENT WITH PFUND SUPERIOR SALES FOR A NEW AMBULANCE VEHICLE FOR USE BY THE EMERGENCY MEDICAL SERVICE; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Hudson EMS has identified its 1999 Freightliner/Horton Ambulance # 4016 being in need of replacement and unsuitable for remount or refurbishing; and

WHEREAS, the City's replacement committee has evaluated similar models from four major ambulance manufacturers and have unanimously recommended the 2023 Ford, Life Line Type 1 "Custom Superliner" as the lowest priced and best option; and

WHEREAS, the City has received a quote for the purchase of such a vehicle from PFund Superior Sales pursuant to "State Term" pricing; and

WHEREAS, the aforesaid equipment and the cost proposal were selected from a State Term Schedule maintained by the State of Ohio Department of Administrative Services and is the from the original vehicle manufacturer, sole source provider, which satisfies the requirements for competitive bidding under the Ohio Revised Code and City law.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Hudson, Summit County, Ohio as follows:

<u>Section 1</u>: That it is in the best interests of the City of Hudson and its operations to purchase 2023 Ford, Life Line Type 1 "Custom Superliner."

<u>Section 2</u>: That the Interim City Manager and/or the Interim City Manager's designee are hereby authorized and directed to enter into a purchase agreement with PFund Superior Sales for the new ambulance vehicle and to sign all necessary paperwork in order to purchase the same, in an amount not to exceed \$300,000.

<u>Section 3</u>: That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

<u>Section 4:</u> That it is found and determined that all formal actions of the Council relating to the adoption of this Resolution were taken in a duly noticed open meeting of this Council and that all deliberations which resulted in formal action were taken in meetings open to the public, in full compliance with all applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

<u>Section 5:</u> That this Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the residents of the City of Hudson by reason of the need to authorize the above payment that is now due and owing; wherefore, this Resolution shall be in effect immediately upon its passage provided it receives the affirmative vote of five members of Council except that six affirmative votes shall be required if all members are present; otherwise it shall be in full force and effect from and after the earliest period allowed by law.
