A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A PURCHASE AGREEMENT WITH CONCORD ROAD EQUIPMENT MFG., INC. FOR THE PURCHASE OF ONE LEAF VACUUM TRAILER FOR PUBLIC WORKS DEPARTMENT OPERATIONS; AND DECLARING AN EMERGENCY.

WHEREAS, the City's Public Works Department is in need of a replacement leaf vacuum trailer to meet the leaf collection program needs of the fast-approaching 2017 autumn season; and

WHEREAS, staff has recommended replacing an existing leaf vacuum trailer outfitted with a manually operated suction hose with a new leaf vacuum trailer outfitted with a hydraulically controlled suction hose will allow the City to more efficiently pick up leaves and will also be safer for City Staff to operate; and

WHEREAS, the City of Hudson has the authority to purchase equipment through the State of Ohio Cooperative Purchasing Program which entity employs competitive bidding processes for equipment; and

WHEREAS, the City has obtained a price quote from Concord Road Equipment Mfg., Inc., Painesville, Ohio, an authorized State of Ohio Cooperative Purchasing Program vendor under State Term Contract No. 800507-STS515, for the purchase of one hydraulically controlled leaf vacuum trailer in the amount of \$69,637.17 for the purpose of replacing equipment at the end of its useful life; and

WHEREAS, this Council has appropriated the funds necessary for the purchase of said equipment to replace equipment in the City's Public Works Department.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Hudson, County of Summit, State of Ohio, that:

Section 1: The City Manager is authorized to enter into a purchase agreement with Concord Road Equipment Mfg., Inc., Painesville, Ohio, under the State of Ohio Procurement State Term Schedule Contract No. 800507-STS515 for the purchase of a hydraulically controlled leaf vacuum trailer in an amount not to exceed \$69,637.17, and as said amount has been appropriated in the City budget.

Section 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3: This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that the aforesaid purchase must be made as soon as possible to both secure the lowest price and be able to provide community leaf collection service during the fast-approaching 2017 autumn season; wherefore, this Resolution shall be in full force and effect immediately upon its passage, provided it receives the affirmative vote of five (5) members of Council elected thereto, or six (6) affirmative votes if all members of Council are present at the meeting at which it is passed; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
