

AN ORDINANCE AUTHORIZING THE SALE OF A HUDSON EMERGENCY MEDICAL SERVICES (EMS) VEHICLE NO LONGER NEEDED FOR MUNICIPAL PURPOSES; AND DECLARING AN EMERGENCY.

WHEREAS, it has been determined by the Emergency Medical Service (“EMS”) Department that, due to the recent retirement of an EMS employee and the subsequent re-assignment of duties, a 2008 Ford Explorer is no longer needed for municipal purposes and therefore the vehicle should be sold; and

WHEREAS, the various safety departments for local governments in the areas near Hudson engage in mutual aid with the City of Hudson, which includes the sharing and/or sale of vehicles between those departments; and

WHEREAS, the Valley Fire District, which serves the Villages of Peninsula and Boston Heights, Ohio, has committed to purchasing the above-described vehicle; and

WHEREAS, the EMS Department has researched prices of similar used vehicles through the Kelly Blue Book to determine a fair market price for this vehicle and has arrived at the value of \$5,000.00, and staff is recommending that the subject vehicle be sold to the Valley Fire District for that amount on an “as-is” basis; and

WHEREAS, pursuant to its home rule authority as exercised through its Charter, City Council wishes to authorize the sale of this personal property which is no longer needed for municipal purposes.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Hudson, County of Summit, State of Ohio, that:

Section 1: The City Manager is authorized to transfer title to the vehicle set forth in the preamble to this Ordinance for the sale amount of \$5,000.00 on an “as-is”, no express or implied warranty basis, to the Valley Fire District.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3: This Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public health, safety and general welfare, and for the further reasons that it is immediately necessary for the City to sell this vehicle which is no longer needed for public use and to enable placement of the vehicle into service with the Valley Fire District for the

improved health and safety of the nearby communities of Peninsula and Boston Heights; wherefore, this Resolution shall be in full force and effect immediately upon its passage, provided it receives the affirmative vote of five members of Council elected thereto, or six affirmative votes if all members of Council are present at the meeting at which it is passed; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
