### 1. Call to Order

**In the absence of President of Council Wooldredge, Dr. Williams called to order the workshop of Hudson City Council at 7:30 p.m., in accordance with the Sunshine Laws of the State of Ohio, O.R.C. Section 121.22.**

### 2. Correspondence and Council Comments

*Dr. Williams reminded citizens that the City is currently accepting applications until May 3, 2019, for the Architectural and Historic Board of Review, Hudson Community Television Advisory Committee, and the Economic Growth Board. He encouraged interested citizens to apply for these volunteer positions. Dr. Williams also said that an At-Large Council Member Open Forum will be held at 7:00 p.m. on April 30, 2019, at Town Hall.*

*Mr. Hanink asked staff to provide a response back to Council at the May 7, 2019 meeting, regarding the letter to the editor that appeared in the Sunday, April 21, 2019 Hudson Hub Times in regards to issues with Broadband.*

*Ms. Bigham stated that she heard that the fields at Barlow Farm Park were recently vandalized and asked staff*

to look into security measures. Ms. Howington stated that she will have staff report back to Council at the May 7, 2019 meeting.

*Mr. Kosco stated that the project limits are on SR 91 from Brandywine Drive, north to Middleton Road. The roadway will only be widened at Herrick Park Drive, Valley View Road, and Hines Hill Road to accommodate new turn lanes.*
