A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A PROFESSIONAL SERVICES CONTRACT WITH DLZ OHIO, INC. FOR THE DESIGN OF THE DILLMAN DRIVE BRIDGE REPLACEMENT PROJECT (PID 119823)

WHEREAS, in September 2023, the City sent out a Request for Proposal to nine (9) ODOT pre-qualified civil engineering consulting firms for the design of the Dillman Drive Bridge Replacement Project; and

WHEREAS, after review of four formal (4) proposals, interviews with the consultants, and consideration of their ODOT experience and understanding of the RFP, the City staff recommends that an agreement be executed with DLZ Ohio, Inc. for the project; and

WHEREAS, DLZ Ohio, Inc is a professional design, engineering and surveying firm and Council may authorize contracts without advertising for bids for professional services; and

WHEREAS, the total design fee for the project totals \$160,097.00, consisting of the base fee of \$130,955, additional services of \$14,588 plus a 10% contingency of \$14,544; and

WHEREAS, design is anticipated to begin in December and continue through August 2024, with bidding of the project Fall 2024 and, due to long lead times for the new bridge's beams, on-site construction planned in Spring/Summer 2025.

WHEREAS, once the project reaches the construction phase, costs up to \$529,029 will be funded with a 5% City match through the ODOT Municipal Bridge Program federal grant that the City previously accepted (see 22-157).

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Hudson, Summit County, State of Ohio, that:

- Section 1. The City Manager is authorized enter into a consulting agreement with DLZ Ohio, Inc for design of Dillman Drive Bridge Replacement Project in an amount not to exceed One Hundred Sixty Thousand Ninety-Seven dollars (\$160,097.00), staff's estimate with an additional 10% contingency.
 - Section 2. That the above recitals are fully incorporated as findings herein.
- Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
