

A RESOLUTION AUTHORIZING THE INTERIM CITY MANAGER TO ENTER INTO A PURCHASE AGREEMENT WITH EXCELLANCE, INC. FOR A REMOUNT AMBULANCE VEHICLE FOR USE BY THE EMERGENCY MEDICAL SERVICE; AND DECLARING AN EMERGENCY.

WHEREAS, as a part of the City's five year plan, Council has tentatively approved the purchase of a replacement remounted ambulance in 2024; and

WHEREAS, due to the long delays, the remounted ambulance is now anticipated to be delivered in early 2025;

WHEREAS, given this delay, City staff has recommended that City Council change the remount of this ambulance from 2024 to 2022; and

WHEREAS, Excellence, Inc., the original manufacture of this ambulance, has presented the option of remounting the current ambulance box on to a new chassis; and

WHEREAS, with every remount, the box is structurally warrantied for 25 more years and the components and wiring are warrantied for 10 years; and

WHEREAS, with City Council approval, the contract could be signed and expected delivery of the newly remounted ambulance to the City of Hudson is estimated to be in April of 2023.

Now, Therefore, Be It Resolved by the Council of the City of Hudson, Summit County, Ohio, that:

Section 1: The City Manager is authorized to enter into a Purchase Agreement with Excellence, Inc. for a Remount Ambulance Vehicle for use by the Emergency Medical Service. The agreement shall be in a form substantially similar to the agreement attached hereto as Exhibit "A", and in a form satisfactory to the City Solicitor.

Section 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section 3: That this Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the residents of the City of Hudson by reason of the need to authorize the above payment that is now due and owing; wherefore, this Resolution shall be in effect immediately upon its passage provided it receives the affirmative vote of five members of Council except that six affirmative votes shall be required if all members are present; otherwise it shall be in full force and effect from and after the earliest period allowed by law.
