

A RESOLUTION AUTHORIZING THE SUBMISSION OF AN APPLICATION BY THE CITY MANAGER'S DESIGNEE TO THE OHIO DEPARTMENT OF DEVELOPMENT FOR FUNDING THROUGH THE BROWNFIELD REMEDIATION PROGRAM; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Hudson is seeking a grant from the Ohio Department of Development through the Brownfield Remediation Program to remediate existing hazardous materials, including concrete pad vapor and mastic materials, and buried pipe insulation, at the former Youth Development Site located on Hines Hill Road (Parcel #3000571);

WHEREAS, in order to timely submit an application for this grant, the City Manager or her designee must submit the grant application to the Ohio Department of Development by a January 31, 2022 deadline so as to help fund the remediation of various hazardous materials located at the former Youth Development Center on Hines Hill Road (Parcel # 3000571);

WHEREAS, the total cost of the project is Two Hundred Eighty-Two Thousand One Hundred Fifty Dollars (\$282,150.00) (100%), which includes design, bidding, inspection, and construction. The funding application is seeking Two Hundred Eleven Thousand Six Hundred Twelve Dollars (\$211,612.00) (75%), and should said funding be awarded, a local match in the amount of Seventy Thousand Five Hundred Thirty-Eight Dollars \$70,538.00 (25%) would be required as part of participation in the grant program; and

WHEREAS, this Council wishes to authorize submission of said application.

NOW THEREFORE, BE IT RESOLVED, by the Council of the City of Hudson, County of Summit, State of Ohio, that:

Section 1: Council hereby authorizes the City Manager's designee to apply for a grant from the Ohio Department of Development for funding through the Brownfield Remediation Program for possible funding assistance under the grant program as set forth in the recitals of this Resolution.

Section 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3: This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, convenience and general welfare of the City of Hudson and the inhabitants thereof, for the reason that to be eligible for the aforesaid funding the City must submit its funding application by January 31, 2022; wherefore, this Resolution shall be in effect immediately upon its passage provided it receives the affirmative vote of five members of Council, except that six affirmative votes shall be required if all

members are present; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
