# MINUTES

Chairman Mitalski called to order the regularly scheduled meeting of the Architectural and Historic Board of Review of the City of Hudson at 7:30 p.m. in the meeting room of Town Hall.

Mrs. Church reported that after using the two meeting review period to visit the site, all members of the Historic District Subcommittee recommended granting a Certificate of Appropriateness with the following condition:

a) The existing three lite windows will be replaced with windows with a matching grid pattern.

### 7. **84 Village Way**

Sign (two building signs and ground sign panel – **Cutler Real Estate**) Submitted by Jim Hinton

Mr. Jim Hinton, the applicant, was present at the meeting. Mr. Hinton provided a letter from the building owner regarding the proposed changes to

the sign plan. There was discussion on the sign plan and the proposed gooseneck light fixtures.

Mr. Wyatt made a motion to approve the sign plan as amended with the following conditions:

- a) All wall signs will be rectilinear panels with the message affixed by paint, vinyl or other similar flat product.
- b) The panels must be located in relation to other architectural features such as windows.
- c) The signs may be illuminated with gooseneck light fixtures.

Mr. Wyatt made a motion to approve the sign plan for Hudson Commerce Center with the following condition:

a) Wall signs are permitted provided they are rectilinear panels that fit completely within the horizontal bands immediately below the roof eaves.

- b) The slider windows will be changed to double hung.
