1070.01 ADVISORY BOARD.

There is hereby created an Ellsworth Meadows Golf Advisory Board to be comprised of two current members of City Council to be appointed by the President of Council, one City of Hudson Park Board Member to be appointed by the Park Board, and three additional Hudson resident members to be appointed by City Council for a four year term commencing January 1, 2009. The Hudson resident members shall serve no more than three consecutive full four-year terms. The Hudson resident members should possess a knowledge of golf course operations, have strong business/marketing abilities and/or construction background.

1070.02 MEETINGS.

The Ellsworth Meadows Golf Advisory Board shall meet at least three times per year, although additional meetings may be scheduled as needed. One meeting shall be prior to the season start to discuss, among other topics, plans for the upcoming golf year, concerns regarding the plans for the upcoming golf season, ways and methods to improve the business product and experience for the golfers at the Ellsworth Meadows Golf Club. A second meeting shall be scheduled during the middle of the golf season to check on the status of the plans and operations of the golf course. A third meeting shall be scheduled at the conclusion of the golf season to review a year-end status report which, after review, shall be provided to the City Manager, City Council Members and other interested parties concerning the progress and status of golf course operations.

1070.03 PURPOSE.

The purpose of the Ellsworth Meadows Golf Advisory Board shall be to help increase/improve the profitability of the Ellsworth Meadows Golf Club as well as keeping apprised Members of the Hudson City Council and City Manager of the financial status along with long-range and short-range goals of the golf course. The Board shall also provide a forum for discussion of ideas to market and advertise the Ellsworth Meadows Golf Club. The Board will assist in bringing ideas to the table that will help the Ellsworth Meadows Golf to be more visible in the golf community and increase the range from which the clientele base is drawn.
