#### 7. Presentation

A. "Prescription Drug Take-Back Day" on April 30, 2016 - Akron Municipal Court Judge Joy Malek Oldfield and Court of Common Pleas Judge Thomas Teodosio will discuss this important program in connection with their work on the Summit County Opiate Task Force.

> Judge Oldfield encouraged citizens to bring unused and unwanted prescription drugs to the Barlow Community Center on Saturday, April 30, 2016, and to refer to www.dea.gov for more information. Mayor Basil thanked her for sharing this information and for her efforts concerning opiate addiction and prevention.

Judge Oldfield presented information on the Prescription Drug Take-Back Day and spoke of ongoing local efforts to combat opiate addiction and prevention.

#### 8. Public Comments

Mr. Greg Hannan spoke on behalf of Leadership Hudson and provided an update to Council regarding Peddle Hudson, the class project to obtain a "Bike Friendly America" Bronze Designation for Hudson. He provided a summary of class activities and efforts, including educational bicycle safety and preventive maintenance classes; bike user map; bike racks; complete streets policy statement; and sustaining bicycle and pedestrian activities (summary and supplemental information is attached to the record copy of these minutes).

### 9. Correspondence and Council Comments

Mr. Kelemen congratulated Hudson City Schools as being recognized again by U.S. News & World Report as one of the leading schools in the country. On behalf of Safe Routes Hudson, he announced that Bike/Walk to School Day is planned for Wednesday, May 4, 2016, and he asked motorists to be cautious and watch out for walkers and cyclists. He reported that a Ward 3 Open Forum was held on March 28, 2016, which was televised on Hudson Cable TV.

considered amendments to the proposed Tax Increment Financing Agreement, as submitted by a School Committee. She provided a detailed summary and said that most changes were not substantive; however, the Schools proposed establishing a cap on the money that could be applied to the TIF District. Ms. Howington did not support this amendment, but she promised that TIF dollars will be used for proposed improvements with specific intent, which would be mutually agreed upon by the City and Schools. She recommended alternate language and noted the public hearing on this Ordinance, scheduled for the May 3, 2016, Council meeting. Discussion followed and City Council members expressed opposition to the substantive amendments proposed by the Schools. Mr. Kelemen was optimistic that the City and Schools could work things out. Mayor Basil agreed, saying that the City and Schools have a history of collaboration and a strong working relationship.

AN ORDINANCE AMENDING SUBSECTION (b) OF SECTION 452.13 "PROHIBITED PARKING IN DESIGNATED PLACES," AND SECTION 410.11 "SCHEDULE XI - PARKING PROHIBITED DURING CERTAIN HOURS IN DESIGNATED PLACES," OF THE TRAFFIC CODE; AND DECLARING AN EMERGENCY.

**Executive Summary:** This legislation will limit the hours vehicles may park in public parking facilities. Such facilities include all public parking areas owned and/or operated by the City of Hudson. There is currently no limit to the amount of time a vehicle can park in or on a public parking facility. Staff wishes Council to approve this legislation to allow for parking enforcement in designated public parking areas.
