

AN ORDINANCE AMENDING SECTION 410.09, SCHEDULE IX, AND SECTION 410.10, SCHEDULE X, OF THE TRAFFIC CODE TO CHANGE TIME LIMITS FOR AND TO PROHIBIT PUBLIC STREET PARKING IN CERTAIN AREAS OF THE CITY; AND DECLARING AN EMERGENCY.

WHEREAS, after discussions with stakeholder groups, the City administration has recommended that certain areas, generally in the Downtown area, have the time limits for public street parking changed and a no parking area designated on a residential street; and

WHEREAS, the revisions to the parking ordinance of the City are timely due to major street and redevelopment projects in the Downtown area.

NOW, THEREFORE, BE IT ORDAINED by the Council of Hudson, Summit County, State of Ohio, that:

Section 1. Section 410.09, Schedule IX, of the Traffic Code is hereby only amended as designated below:

“410.09 SCHEDULE IX – PARKING TIME LIMITED IN DESIGNATED PLACES.

Following are the streets and portions of streets in the City on which parking is limited:

Section 2. Existing Section 410.09, Schedule IX, of the Traffic Code is hereby repealed.

Section 3. Section 410.10, Schedule X, of the Traffic Code is hereby only amended to add the designated text below:

“410.10 SCHEDULE X - PARKING PROHIBITED AT ALL TIMES IN DESIGNATED PLACES.

Following are the streets and portions of streets in the City on which parking is prohibited at all times:

Section 4. Existing Section 410.10, Schedule X, of the Traffic Code is hereby repealed.

Section 5. This Ordinance is an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the residents and motorists in the City and for the further reason that the safety of pedestrians and the motoring public needs to be enhanced at the earliest possible time given various public improvement projects in the Downtown area and otherwise; wherefore, it shall take effect and be in force immediately upon passage, provided it receives five (5) affirmative votes of members of Council, except that six (6) affirmative votes are required if all members are present; otherwise it shall be in full force and effect from and after the earliest period allowed by law.
