Mayor Basil called to order the public hearing for Ordinance 16-87 at 7:47 p.m. There being no comments, Mayor Basil closed the public hearing at 7:48 p.m.

A public hearing was held regarding Ordinance No. 16-87.

9. Public Comments

Janice Daltorio, 7822 Valley View Road, questioned the fencing requirements in Ordinance No. 16-44. She stated that permeant fencing breeds disease in chickens and that free-range allows for healthier chickens. She also questioned if the language regarding the breeding of animals or sales of agricultural goods meant that residents would not be able to sell eggs. Mr. DeSaussure stated that eggs could only be sold by those residents that have an agricultural use permit. She also asked if a property owner has 10 acres of land, would the maximum number of chickens be limited to 18 chickens. Mr. DeSaussure stated that the limit only applies to those that do not have an agricultural use permit. Ms. Daltorio expressed her objection to this Ordinance and urged Council to reconsider the fencing requirement.

Dr. John Durfee, 8135 Valley View Road, expressed concerns regarding Ordinance No. 16-44, specifically with the fencing requirement, and he urged Council to look at alternate forms of fencing requirements.

Joe Daltorio, 7822 Valley View Road, spoke in regards to Ordinance No. 16-44. He stated that the keeping of chickens has a lot less impact on land than many might expect. He noted that according to the Missouri Extension, one Canada goose produces the same amount of manure in one day as 18 chickens.

10. Correspondence and Council Comments

Mayor Basil provided an update as part of the Keep Hudson Safe Initiative, with heroin addiction being the key focus. He stated that the most recent update from the Summit County Department of Health stated that from July 25, 2016, through July 18, 2016, there have been 48 drug-related overdoses in Summit County, one of those being from Hudson. He said that this data was received from local emergency rooms. Mayor Basil urged those that are dealing with an issue or know of someone dealing with an issue to seek help. He noted two help lines, one through the local schools and police and the other being 3-1-1, which is a local number for Summit County.

Mr. DeSaussure announced that there will be an executive session held at the end of the meeting to consider the purchase of property for public purpose.

11. Report of Manager

Ms. Howington stated that the City has been receiving calls from residents within the Brandywine Watershed regarding invoicing that they have received from the Northeast Ohio Regional Sewer District (NEORSD). She stated that these invoices are for storm water drainage, pursuant to court action approving invoicing of those that live within that specific watershed. Ms. Howington directed residents to visit the City's website, which includes more information and contacts for NEORSD. She noted that NEORSD manages this program.

In addition, she asked Council to pass Ordinance No's. 16-123, 16-124 and 16-125, as emergency measures tonight, and she explained that these Ordinances pertain to rollover notes that come due on Thursday, July 21, 2016.

Executive Summary: In discussions with the downtown merchants' associations and business representatives over a period of several months, the City administration has been asked to re-evaluate the downtown parking codes, implement more two (2) hour parking areas, and increase parking code enforcement. Staff believes there is now consensus among the downtown stakeholders as to an acceptable parking plan. Staff wishes to now make the necessary code amendments to implement the parking plan.

Mr. Weinstein asked whether it mattered if permeant fencing or mobile fencing was utilized, as long as it adhered to the guideline requirements. Mr. Richardson stated that this Ordinance would not prevent residents from utilizing portable fencing as long as all of the setback requirements are met. Mr. Weinstein stated that this Ordinance will set-up a process that is understandable to residents.

Mr. Wooldredge stated that this Ordinance only pertains to residential use, and that anyone choosing to raise a lot of chickens could apply for an agricultural use permit.

Mayor Basil asked Mr. Richardson to explain the process to obtain an agricultural use permit. Mr Richardson explained the process.

Mr. DeSaussure clarified that it was never Council's intention to make changes to horse use in town, and that this Ordinance has always been geared to the raising of chickens in residential areas. As the Code went through its various drafts, there was language added regarding horses, and when Council saw the latest draft at the Workshop on July 12, 2016, this language was removed. Furthermore, he stated that he did not support this Ordinance due to concerns with the ability to be able to keep up with enforcement, from both a regulatory standpoint and a health standpoint.

Dr. Williams stated that he had been contacted by numerous residents that are upset with chickens roaming into neighbors' yards because of not being properly fenced. He stated that he did not feel that there will be an

overwhelming amount of people raising chickens in residential areas, and he expressed support for this Ordinance, saying that there is a need for it.

Mr. Wooldredge stated that he also had been contacted by numerous residents that are upset with chickens roaming in their neighborhoods. He stated that as the Ordinance is currently written, there is an enforcement issue. Mr. Richardson stated that with the current Ordinance, chickens are only allowed if you have an agricultural designation.

Mrs. Bigham asked if there is an acreage requirement in order to apply for an agricultural use permit. Mr. Richardson stated that agricultural use permits are only allowed within certain zoning districts, and that agricultural use permits are not currently allowed within a residential zoning district.

Mr. Kelemen agreed that enforcement could be an issue, but he felt that enforcement should not be a reason to not pass this Ordinance. He said that this Ordinance will give the City something to use for enforcement.
