AN ORDINANCE ADOPTING THE ENGINEERING STANDARDS FOR INFRASTRUCTURE CONSTRUCTION AND DIRECTING THEIR CODIFICATION INTO CHAPTER 1419, "ENGINEERING STANDARDS FOR INFRASTRUCTURE CONSTRUCTION," OF THE CODIFIED ORDINANCES.

WHEREAS, pursuant to Resolution No. 99-117, adopted by this Council on September 15, 1999, Sections 2, 3, 4, 5, 6 and 8 of the Engineering Standards for Infrastructure Construction were included in the Land Development Code, and were adopted by reference into Chapter 1419, "Engineering Standards for Infrastructure Construction" of the Codified Ordinances; and

WHEREAS, the Engineering Standards for Infrastructure Construction were thereafter amended by Resolutions 00-116, 01-131, 02-106 and 15-62; and

WHEREAS, Section 7 of the Engineering Standards for Infrastructure Construction has been recently amended by staff to include provisions to be removed from Section 1207.13, "Transportation/Circulation/Pedestrian Linkage," of Chapter 1207, "Zoning Development and Site Plan Standards," of the Land Development Code, and those amendments are included in the Engineering Standards for Infrastructure Construction dated October 6, 2016 and being adopted by this Ordinance; and

WHEREAS, in an effort to streamline publication of the Codified Ordinances, City staff has recommended that the Engineering Standards for Infrastructure Construction be included in Chapter 1419, "Engineering Standards for Infrastructure Construction" of the Codified Ordinances; and

WHEREAS, this Council believes it is in the best interest of the City to adopt the Engineering Standards for Infrastructure Construction dated October 6, 2016 and to direct their codification into Chapter 1419, "Engineering Standards for Infrastructure Construction," of the Codified Ordinances.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Hudson, County of Summit, State of Ohio, that:

<u>Section 1</u>. This Council approves and adopts the Engineering Standards for Infrastructure Construction dated October 6, 2016. A true and accurate copy of these standards is on file with the Clerk of Council.

Section 2. The Engineering Standards for Infrastructure Construction shall be codified into Chapter 1419, "Engineering Standards for Infrastructure Construction," of the

Codified Ordinances of the City of Hudson and the Clerk of Council is authorized and directed to take all actions necessary to complete such codification.

<u>Section 3</u>. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and of any its committees that resulted in such formal action, were held in meetings that were open to the public, in compliance with all legal requirements.

<u>Section 4</u>. This Ordinance shall take effect and be in full force from and after the earliest period allowed by law.
