AFTER THE EXPIRATION OF THE INITIAL TERM, THIS SO SHALL AUTOMATICALLY RENEW FROM MONTH TO MONTH UNDER THE SAME TERMS AND CONDITIONS AS STATED HEREIN (EXCEPT THAT WIN MAY CHANGE THE MONTHLY LEASE FEE FOR THE SERVICES UPON THIRTY (30) DAYS NOTICE), UNLESS EITHER PARTY TERMINATES BY PROVIDING WRITTEN NOTICE OF TERMINATION TO THE OTHER PARTY NOT LESS THAN THIRTY (30) DAYS PRIOR TO THE EXPIRATION OF THE THEN CURRENT TERM.
- Change in Services.** If this is a change to Services in an existing SO (upgrade, reduction or increase in services, etc) the following terms apply:
  - SO # \_\_\_\_ (the "Existing SO") is hereby superseded by this SO. The Services in such SO are being changed as follows:\_\_\_\_\_.
  - The Service Commencement Date for purposes of this new SO is the date that the change in the Service occurs.
  - Liquidated damages: *(check one)*
    - The liquidated damages/early termination fees applicable to early termination of the Existing SO are \$ \_\_\_\_\_ ; OR
    - \*In consideration of Customer's change in service, Windstream agrees that no liquidated damages or early termination fees apply to the early termination of the Existing SO; however, should this SO be terminated early, the liquidated damages or early termination fees set forth in the MSA shall apply.
- Construction Efforts.** If this SO indicates that Construction is required, Customer agrees that notwithstanding any provision in the MSA to the contrary, Customer may not terminate this SO without early termination liability, regardless of reason or cause. As such, if on or after the Service Commencement Date, Customer terminates this SO or if Windstream terminates this SO for Customer's material breach or failure to pay sums due hereunder or under the MSA, Customer will pay Windstream within ten (10) days of the effective date of termination: (i) for all Services previously rendered with respect to this SO; and (ii) an amount equal to 100% of the Monthly Lease Fee (plus taxes and fees) for the Service multiplied by the number of months remaining in this SO term. Such amounts constitute liquidated damages, not a penalty.
