OFFERED BY: MAYOR BASIL

A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO CONTRACTS FOR THE PURCHASE OF THREE VEHICLES FOR THE POLICE DEPARTMENT; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Hudson has the authority to purchase vehicles through the State of Ohio Cooperative Purchasing Program; and

WHEREAS, pursuant to City Charter, Section 6.04 of Article VII, as a member of the Community, University & Education Purchasing Association (C.U.E.) purchasing cooperative, the City of Hudson is permitted to purchase vehicles through the C.U.E. competitive bidding process; and

WHEREAS, the City has obtained prices from Byers Chevrolet, Grove City, Ohio, and Lebanon Ford, Lebanon, Ohio, under the State of Ohio Procurement State Term Schedule Contract No. RS900917 for one 2017 Chevrolet Tahoe in the amount of \$34,950.00 and for one 2017 Ford Utility Interceptor in the amount of \$26,670.00 respectively after receiving quotations from other vendors for the purpose of replacing two police vehicles at the end of their useful lives; and

WHEREAS, the City has obtained a price from Montrose Ford, Montrose, Ohio, through the C.U.E. bidding process for one 2017 Ford Fusion in the amount of \$17,953.29 after receiving quotations from other vendors for the purpose of replacing one police vehicle at the end of its useful life; and

WHEREAS, this Council has appropriated the funds necessary for the purchase of three (3) vehicles to replace vehicles in the City's vehicle fleet for the Police Department.

NOW, THEREFORE, Be It Resolved by the Council of the City of Hudson, County of Summit, State of Ohio, that:

<u>Section 1</u>: The City Manager is authorized to enter into purchase agreements with Byers Chevrolet, Grove City, Ohio, and Lebanon Ford, Lebanon, Ohio, under the State of Ohio Procurement State Term Schedule Contract No. RS900917 for one 2017 Chevrolet Tahoe at a total cost not to exceed \$34,950.00 and for one 2017 Ford Utility Interceptor at a total cost not to exceed \$26,670.00 respectively, and as said amounts have been appropriated in the City budget.

<u>Section 2:</u> The City Manager is authorized to enter into a purchase agreement through the C.U.E. purchasing program with Montrose Ford for the purchase of one 2017 Ford Fusion at a total cost not to exceed \$17,953.29, and as said amount has been appropriated in the City budget.

<u>Section 3</u>: This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary to purchase the three vehicles to maintain police patrols in the City; wherefore, this Resolution shall be in full force and effect immediately upon its passage, provided it receives the affirmative vote of five (5) members of Council elected thereto, or six (6) affirmative votes if all members of Council are present at the meeting at which it is passed; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
