- B. [17-0014](#) **Discussion: SR 91 and SR 303 Intersection Improvement Project Discussion.**
Executive Summary: The City of Hudson Engineering Department applied to the AMATS (Akron Metropolitan Area Transportation Study) for an STP Grant in 2015-16. The application was approved and the City is prepared to draft a Request for Proposals (RFP) for the design of this project in the future. Staff would like to discuss the project and its potential impacts on the Hudson downtown area with City Council.**

Mr. Sheridan and Mr. Papp explained the changes that are needed to increase better traffic flow through the intersection and asked Council for guidance on design parameters. Council had concerns with truck traffic, pedestrian safety, and taking green space. Council asked staff to put together some conceptual designs and bring them back to Council for review.
