A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO CONTRACTS FOR THE PURCHASE OF FIVE FLEET VEHICLES FOR HUDSON COMMUNITY TELEVISION (HCTV), SERVICE DIVISION AND HUDSON PUBLIC POWER (HPP) OPERATIONS AND TO OUTFIT TWO OF SAID SERVICE DIVISION VEHICLES WITH EQUIPMENT; AND DECLARING AN EMERGENCY.

WHEREAS, pursuant to City Charter, Section 6.04 of Article VII, as a member of the Community, University & Education Purchasing Association (C.U.E.) purchasing cooperative, the City of Hudson is permitted to purchase vehicles through the C.U.E. competitive bidding process; and

WHEREAS, the City of Hudson has the authority to purchase vehicles and related equipment through the State of Ohio Cooperative Purchasing Program and the State Department of Transportation contract which entities employ competitive bidding processes for vehicles and equipment; and

WHEREAS, the City has obtained prices from Montrose Auto Group, Montrose, Ohio, through the C.U.E. bidding process for two 2017 Ford Transit Vans in the amounts of \$27,073.21 for HCTV operations and \$28,411.02 for HPP operations, one Ford F250 with plow for Service Division operations in the amount of \$35,001.04, and one Ford F550 Cab and Chassis for Service Division operations in the amount of \$36,511.39 for the purpose of replacing four vehicles at the end of their useful lives; and

WHEREAS, the City has obtained a price from Valley Freightliner, Cleveland, Ohio, under Ohio Department of Transportation (ODOT) pricing (023-16) for one 2017 Freightliner Cab and Chassis 108SD in the amount of \$88,365.00 for the purpose of replacing one vehicle at the end of its useful life; and

WHEREAS, the City has obtained a price from Concord Road Equipment, Painesville, Ohio, under the State of Ohio Procurement State Term Schedule Contract No. STS515-800507 for the purchase and installation of an LAS brine system with hook lift and plow to be installed on aforesaid Freightliner Cab and Chassis 108SD in the amount of \$101,681.04 for the purpose of equipping the vehicle for brine applications and replacing plowing equipment at the end of its useful life; and

WHEREAS, staff received competitive bids for the purchase and installation of a service body equipment package for aforesaid Ford F550 Cab and Chassis and has recommended said purchase from Zoresco Equipment Company, Turtle Creek, Pennsylvania, as the lowest and best bidder in the amount of \$38,411.00 for the purpose of equipping the vehicle for water main repairs and replacing equipment at the end of its useful life; and

WHEREAS, this Council has appropriated the funds necessary for the purchase of one (1) vehicle to replace a vehicle in the City's vehicle fleet for HCTV, one (1) vehicle to replace a vehicle in the City's vehicle fleet for HPP, one (1) vehicle to replace a vehicle in the City's vehicle fleet for the Service Division, and two (2) vehicles with equipment to replace vehicles with equipment in the City's vehicle fleet for the Service Division.

NOW, THEREFORE, Be It Resolved by the Council of the City of Hudson, County of Summit, State of Ohio, that:

- Section 1: The City Manager is authorized to enter into purchase agreements through the C.U.E. purchasing program with Montrose Auto Group, Montrose, Ohio for the purchase of two 2017 Ford Transit Vans, one Ford F250 with plow, and one Ford F550 Cab and Chassis at a total cost not to exceed \$126,996.66, and as said amount has been appropriated in the City budget.
- Section 2: The City Manager is authorized to enter into a purchase agreement pursuant to ODOT pricing with Valley Freightliner, Cleveland, Ohio, for the purchase of one 2017 Freightliner Cab and Chassis 108SD at a total cost not to exceed \$88,365.00, and as said amount has been appropriated in the City budget.
- Section 3: The City Manager is authorized to enter into a purchase agreement with Concord Road Equipment, Painesville, Ohio, under the State of Ohio Procurement State Term Schedule Contract No. STS515-800507 for the purchase and installation of an LAS brine system with hook lift and plow equipment to be installed on aforesaid Freightliner Cab and Chassis 108SD at a total cost not to exceed \$101,681.04, and as said amount has been appropriated in the City budget.
- Section 4: The City Manager is authorized to enter into a purchase agreement with Zoresco Equipment Company, Turtle Creek, Pennsylvania, as the lowest and best bidder, for the purchase and installation of a service body equipment package for aforesaid Ford F550 Cab and Chassis at a total cost not to exceed \$38,411.00, and as said amount has been appropriated in the City budget.
- Section 5: This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that the aforesaid purchases must be made as soon as possible to secure the specific vehicles and equipment for the provision of critical public services and to secure the lowest prices; wherefore, this Resolution shall be in full force and effect immediately upon its passage, provided it receives the affirmative vote of five (5) members of Council elected thereto, or six (6) affirmative votes if all members of Council are present at the meeting at which it is passed; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
