2017 Hudson Bike and Pedestrian Plan

Purpose: The City of Hudson Bike and Pedestrian Plan is being pursued for the following reasons:

- 1. Revise the connectivity plan as several funded trails and recent private development activity have impacted routing and priorities.
- 2. Determine the cost and possible funding sources for implementation and ongoing maintenance.
- 3. Review the Safe Routes Hudson travel plan to determine infrastructure needs and opportunities.
- 4. Determine pedestrian and bicycle improvements beyond the connectivity plan including crosswalks, minor connections, sharrows, signage, and public education/safety.
- 5. Revise the plan update to a holistic Bike and Pedestrian Plan to look at Bike/Ped issues and to remove the "connectivity" confusion with Velocity Broadband.

Stakeholders Committee (3-4 meetings June-Sept): City Council, School District, Safe Routes Hudson, Health Dept, Hudson Velo Club, Burton D. Scope Summary (May-September):

- 1. Define Vision, Goals and Objectives
- 2. Public Engagement online survey, workshop to prioritize programs, follow up meeting to review draft findings, open streets event.
- 3. Utilize the 5 Es of the American League of Cyclists:
 - A. Engineering:
 - a. Update/refresh connectivity plan
 - i. Define typology regional, connector, neighborhood
 - ii. Define surface- paved, compacted stone, natural surface
 - b. Infrastructure ADA ramps, crosswalks, bike racks, lighting, Ped signals
 - c. Update Safe Routes travel plan
 - d. Maintenance strategies and schedules
 - B. <u>E</u>ducation: Partner w/ community organizations to promote safe biking/walking
 - C. Encouragement: Bike/walk commuting, Open Streets Ride, Signage, Wayfinding
 - D. Enforcement:
 - a. Bike Friendly Laws review of Codified Ordinances and LDC
 - b. Complete Streets expand on resolution to a more detailed framework
 - E. <u>E</u>valuation and Planning:
 - a. Advisory steering committee transferred into ongoing implementation committee
 - b. Capital Improvement plan with funding strategies
- 4. Implementation: Transition stakeholder group into an ongoing advisory group to meet quarterly to guide implementation and manage the education and public awareness programs.
