### I. Call To Order

Acting Chair Marzulla called to order the regularly scheduled meeting of the Architectural & Historic Board of Review of the City of Hudson at 7:30 p.m., in accordance with the Sunshine Laws of the State of Ohio, O.R.C. Section 121.22.

Mr. Steve Church, 144 Elm Street, asked to consider including the 1927 portion of the Middle School in the proposed Historic District expansion. He said he gathered 100 signatures from 60 households in support of this effort. Ms. Marzulla stated that the petition was received and the Board will consider including this property in the proposed expansion area.
