Chief Robbins -

The 2018 City of Hudson Budget provides for the replacement of two police patrol vehicles.

In accordance with our replacement schedule and based upon the current mileage, age, and overall condition, I recommend replacing marked cruisers # 3 and # 8 (both are 2015 Ford NGPI-Utility with Fleet ID's 1169 & 1170) with new models of the same vehicles.

For these marked cruisers, Ohio State Contract number RS900718 (New, Model Year 2018 or Manufacturers's Current Production Model - Law Enforcement Vehicles - effective through 09/30/2018) was awarded to dealer Lebanon Ford to supply the State of Ohio and political subdivisions with 2018 Ford NGPI-Utility vehicles. The Ohio STS pricing was again lower this year than other cooperative purchasing programs (GSA, CUE) for these law enforcement specific vehicles.

Historically, local dealers have cited not being able to compete with Ohio State Term contract pricing and decline the opportunity to provide a quotation. This was the case again this year when I spoke with Klaben and Montrose Ford. They both confirmed that their dealer pricing from Ford is higher than the end cost to Ohio public entities purchasing through the Ohio STS program.

I recommend to you and City Council that legislation be passed authorizing a \$54,528 purchase order be issued to Lebanon Ford to supply our 2018 replacement police vehicles:
