A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A PROFESSIONAL SERVICES CONTRACT WITH O.R. COLAN ASSOCIATES, INC. FOR RIGHT-OF-WAY ACQUISITION SERVICES FOR THE STATE ROUTE 91 NORTH TURN LANE IMPROVEMENTS PROJECT (PID 93822); AND DECLARING AN EMERGENCY.

WHEREAS, the State Route 91 North Turn Lane Improvements Project involves roadway widening and other improvements that require the acquisition of temporary and permanent right-of-ways, affecting approximately 47 parcels along State Route 91; and

WHEREAS, staff recommends awarding a contract to O.R. Colan Associates, Inc. for professional right-of-way acquisition services, including title research, fair market value appraisals and estimates, communications with affected property owners, and negotiations of sale prices for affected properties, in an amount of \$217,864.50, which includes a five percent (5%) contingency for scope of service changes that may occur; and

WHEREAS, Federal funding is available for professional services relating to this project for appraisal review and right-of-way acquisition, and staff proposes the use of \$123,060.00 in Federal funding for right-of-way acquisition services. The Engineering Department will fund a total of \$68,647.50, and staff has requested a supplemental appropriation of \$26,157.00; and

WHEREAS, this Council wishes to award said contract to O.R. Colan Associates, Inc.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Hudson, County of Summit, State of Ohio, that:

Section 1: The City Manager is authorized to enter into a contract with O.R. Colan Associates, Inc., for professional services to conduct right-of-way acquisition services for the State Route 91 North Turn Lane Improvements Project in an amount not to exceed two hundred and seventeen thousand eight hundred and sixty four dollars and fifty cents (\$217,864.50), which includes a five percent (5%) contingency for scope of service changes that may occur.

Section 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3. This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary to begin the process of right-of-way acquisitions at the earliest possible time for this project that will further the public health, safety and general welfare; wherefore, this

Resolution shall be in effect immediately upon its passage provided it rece	ives the affirmative vote
of five members of Council, except that six affirmative votes shall be req	uired if all members are
present; otherwise, it shall be in full force and effect from and after the ea	rliest period allowed by
law.
