Ordinance No. 15-124

Mayor Currin opened the public hearing for Ordinance No. 15-124 at 7:38 p.m.

Mr. Jerry Unroe, Co-Chair of the Tree Commission and resident of 1484 Carriage Hill Drive, spoke on behalf of the Commission and requested that an amendment be made to the draft Comprehensive Plan regarding tree canopy preservation. He explained the value and impacts of tree canopy, such as improved quality of life, higher property values, less erosion and flooding, and citizens spending more time outside. He said that Hudson's tree canopy is currently estimated at 43%, and the Tree Commission is recommending a goal of 45%. He explained the importance of establishing this identifiable goal to protect Hudson's environment, referring to the Ohio EPA Exchange Program which allows developers to substitute tree plantings and clearings in different areas of the state at no net loss. He said that the Tree Commission is willing to assist with development of language for an amendment. Mayor Currin thanked Mr. Unroe for bringing this matter to Council's attention and for his service on the Tree Commission.

Mr. Bob Drew, Chairman of the Comprehensive Plan Steering Committee and resident of 66 East Streetsboro Street, congratulated the newly elected City officials and Mayor Currin for his many years of service. He thanked Comprehensive Plan Steering Committee members, staff, and the consultant on a fine job in preparation of the proposed Comprehensive Plan, and he expressed support for its adoption by City Council.

Mayor Currin thanked Mr. Drew for his comments and for his service to the City.

Mayor Currin closed the public hearing for Ordinance No. 15-124 at 7:45 p.m.

7. Public Comments

Mr. Paul Bodden, 200 Laurel Lake Drive, Apt. E168, commented on the immense, meaningful and continuing contributions that Mayor Currin and his wife, Debbie, have made to the Hudson community. He thanked Mayor Currin for his public service and for sharing his time, talent and treasure with the City as an EMS volunteer, Board of Education Member, Council Member, and Mayor. He saluted Mayor and Mrs. Currin and said that their long-term efforts have helped to make Hudson the wonderful community that it is. (See comments attached to record copy of these minutes). Mayor Currin expressed gratitude for Mr. Bodden's generous comments and thanked him and his wife, Molly, for their many contributions to the community.

Mr. DeSaussure noted that this was Mayor Currin's last meeting. He agreed with comments made by Mr. Bodden and said that it has been an honor and privilege to have served with Mayor Currin. All other Council members agreed and expressed similar appreciation to Mayor Currin for his service.

Mr. Wooldredge reported that two new members of the Economic Growth Board were sworn-in at the November 12, 2015, meeting. He said that the EGB discussed the Community Improvement Corporation and will continue to pursue its use in the future. In addition, he said that Ms. Howington discussed current and upcoming City projects that the EGB might be participating in.

9. Report of Manager

Ms. Howington said that City staff had the honor and privilege to attend an open house for Mayor Currin yesterday. On behalf of the entire City staff, she thanked Mayor Currin for his involvement, dedication and guidance. Mayor Currin thanked Ms. Howington and said that the open house was meaningful and rewarding. He commented that the City's staff is second to none.

Ms. Howington said that City offices will be closed for the Thanksgiving holidays on November 26-27, 2015. She invited citizens to participate in "Home for the Holidays" and shop locally. She said that the Leaf Collection Program continues, and she anticipated that the City will pick up more leaves this year than last year. Finally, she reported that fire fighters had been called to a large brush fire in the City earlier that afternoon, for which mutual aid used. She said the event was well handled and coordinated, the fire burned several acres, but there was no property damage.
