Mr. Kelemen commented that the Broadband Project had been discussed as a pilot project, but Resolution No. 15-121 referred to marketing services through 2016. His preference was for Council to fund marketing efforts through 2015 and discuss further expenditures during 2016 Budget deliberations. He proposed tabling this Resolution.

Mr. DeSaussure expressed opposition to tabling the Resolution, explaining that the Broadband Project is a Council priority, ongoing marketing efforts are important, and the contract amounts are stated as "not to be exceeded," which provides flexibility to staff. Remaining Council members also expressed opposition to tabling Resolution No. 15-121. Responding to Mr. Hanink's inquiry, Ms. Howington explained that costs of preliminary broadband marketing to date have been funded by allocations for Economic Development, but the City can make a journal entry to adjust and track all related expenses in the Broadband Fund.

Mayor Currin read the title of Ordinance No. 15-127, which constituted its first reading.

Mr. Basil said that the issue of Council member compensation has been formally considered earlier this year by the 2015 Charter Review Commission and by City Council. He expressed support for raising the current rate of compensation and said that it is appropriate to let voters make the decision. Remaining Council members expressed support for passage of Ordinance No. 15-127. Mayor Currin explained that he had introduced this Ordinance and said that, if approved by voters, the Charter amendment would reflect a minor change in compensation, and the rate would equal that earned by Hudson Board of Education members. He said that a change would make an appropriate impact, so that no Council member is affected adversely by miscellaneous costs in order to serve in a manner that it is expected. He said that Council's work has become increasingly more difficult through the years, and this proposed Charter amendment would ensure that all ages and genders have the ability to serve. Mayor Currin encouraged Council members to put this matter to public vote with passage of Ordinance No. 15-127.
