1. Call to Order

Mayor Basil called to order the meeting of Hudson City Council at 7:30 p.m., in accordance with the Sunshine Laws of the State of Ohio, O.R.C. Section 121.22.

4. Approval of the Minutes

There being no changes, the above minutes were approved as submitted.

5. Public Comments

Mr. Greg Janik, 36 Thirty Acres, spoke regarding the adjacent Thirty Pines property, which is owned by Mr. Perry Bourn and Mr. John Carse, and Morning Star Farm, owned by the Steidls. He shared that Mr. Carse is considering purchasing the Morning Star property from Mr. Steidl, which would open up more than 40 acres for development. He said that such development would impact traffic on State Route 91 and is a major concern for area residents, he urged City Council to consider preserving these properties as park land, noting mineral and gas rights. He said that Mr. Steidl had wanted to farm the property, but the City would not allow this use under current zoning.

Mr. Janik also spoke in opposition to the current fertilization program for the public greens, and he urged the City to discontinue use of harmful chemicals on public properties.

Mrs. Sue Lynch said that she and her husband are partial owners of LifeCenter Plus, and she spoke regarding the Community Reinvestment Area application currently before City Council, (Resolution No. 16-160). She said that the developer has requested a tax abatement for a facility and business that would directly conflict with Hudson Community Education & Recreation and LifeCenter Plus. She said that granting the CRA would give this new business a competitive step-up, and she asked that Council consider fair grounds for all businesses.

6. Correspondence and Council Comments

Mayor Basil noted that October 5th is International Walk / Bike to School Day, and he asked motorists to use extra caution due to the large number of participants expected for this annual Safe Routes Hudson event.

Mr. Kelemen agreed and said that Safe Routes Hudson will be providing flashing safety lights to participating students to provide enhanced visibility. He also encouraged the community to attend the Fire Safety Open House, planned on October 9th at the Hudson Fire Department.

7. Report of Manager

Mr. Comeriato made the following announcements: leaf program will be underway during October 24 -November 28, detailed information, including a map, is available online and in upcoming editions of the Hudson Hub-Times; October 8th is the final Farmers Market, thanks to everyone involved in making this seasonal program a success; Main Street Project update, reference City's website for more information; and hydrant flushing during October 10 - 21.
