1. Call to Order

President of Council DeSaussure called to order the workshop meeting of Hudson City Council at 7:30 p.m., in accordance with the Sunshine Laws of the State of Ohio, O.R.C. Section 121.22.

2. Correspondence and Council Comments

Mr. Kelemen reported on the Environmental Awareness Committee meeting and mentioned that they appreciate Council allowing them to discuss recycling in Downtown Phase II at the August 23, 2016 workshop. He said that the Environmental Awareness Committee will also be preparing a separate presentation, for a later date, regarding simple recycling. He also noted that Green on the Green will take place on September 17, 2016.

Mr. Kelemen expressed concerns regarding the Complete Street Resolution that was passed on August 2, 2016, discussion followed. He further stated that he was not able to find the updated Comprehensive Plan on the City's website.

Dr. Williams requested discussion regarding the Norfolk Southern Culvert Project. Ms. Howington stated that this is scheduled for discussion at the August 23, 2016 workshop.

Mr. Hanink requested discussion regarding additional funds being added to this year's road program and/or storm sewer work. Ms. Howington stated that this information is being compiled and will be brought to the August 23, 2016 workshop.

3. Discussion Items: Legislation and Other

A. <u>16-0079</u> Joint Discussion with Park Board Regarding the 4 Proposed Phases of the Veterans Trail Projects.

Executive Summary: City staff will make a presentation to City Council and the Park Board of the four (4) proposed phases of the Veterans Trail Projects with respect to the proposed alignments, financial impacts, and environmental concerns.

Mr. Sheridan presented information regarding the proposed plans for the 4 phases of Veterans Trail. General discussion followed regarding: Phase 2 constraints and options including the Ohio Edison power line easement, Ohio Edison easement on the former Chalet property, grant monies received, and Phase 1 path layout through the former Youth Development Center property.

There was general consensus to build Phase 2 on the alternate route, from Prospect Street to Hunting Hollow to Valley View Road to SR 91.

This matter was discussed.

B. <u>16-0081</u> Discussion of potential site locations for a new Municipal Services Center (MSC) Building

Executive Summary: Staff will present potential sites for a new MSC building for general discussion with City Council.

Ms. Howington reviewed the timeline, needs assessment, and location options for the new Municipal Services Center.

Council requested that staff look at surrounding communities to see what type of city buildings they have and how the space is utilized. Staff will return to a Council workshop in November to further discuss the new Municipal Services Center.

This matter was discussed.

AN ORDINANCE TO SUBMIT TO THE ELECTORS OF THE CITY OF HUDSON THE QUESTION OF AMENDING THE CHARTER AT ARTICLE VI, SECTION 6.02, TO REVISE THE INCOME TAX CREDIT FOR CITY RESIDENTS WHO PAY INCOME TAX TO ANOTHER MUNICIPALITY OR JOINT ECONOMIC DEVELOPMENT DISTRICT; AND DECLARING AN EMERGENCY.
