**Executive Summary:** This Resolution recognizes Kelly Marie Potter for her compassionate caring, quick thinking, and effective performance of life support measures to help save the lives of two citizens in our community, victims of choking and cardiac arrest incidents.

Mayor Basil read Resolution No. 17-124 in its entirety, recognizing and thanking Mrs. Potter. Mrs. Bigham said that Mrs. Potter is an inspiring and caring person. Mrs. Potter thanked elected officials for the recognition and noted that she did not act alone and that other bystanders participated in these life-saving events. She encouraged everyone to recognize opportunities in their lives where they can take action to help others. She reported that the gentleman who had suffered a cardiac arrest has donated 3 new automatic external defibrillators to Dr. Terry Gordon's national campaign to help ensure that an AED is placed in every school in our country.

## B. <u>17-125</u> A RESOLUTION THANKING MR. ROBERT SWEDENBORG FOR HIS SERVICE TO THE HUDSON COMMUNITY.

**Executive Summary:** This Resolution provides recognition and thanks to Rob Swedenborg for his dedicated service as a member of the Hudson Park Board.

Mayor Basil read Resolution No. 17-125 in its entirety and thank Mr. Swedenborg for his service on the Park Board. Mr. Kelemen thanked Mr. Swedenborg for his passion and drive, as demonstrated not only by his contributions to the parks, but also by his efforts in support of the Library and his service as a local school teacher. Mayor Basil said that Mr. Swedenborg has been a tireless supporter of the community, and he thanked him for his passion and professionalism. Mr. Swedenborg thanked Council for the opportunity to serve on the Park Board. He also thanked Mr. Hutchinson for his assistance and Ms. Kadish for her leadership as the most recent Park Board Chair.

#### 6. Public Comments

Mr. Tim Lelko, 55 Owen Brown Street, commented regarding how the Downtown Phase II will affect Owen Brown Street residents, expressing concerns regarding density, parking, increased traffic in downtown, through-traffic on Owen Brown St., architectural integrity, contamination, remediation, and the sale price of the City's property for the developer. He encouraged Council to consider options to address these concerns (see statement attached to record copy of these minutes).

Mrs. Jill Flagg, 64 Owen Brown Street, said that the library was a great anchor in Downtown Phase I, and she encouraged Council to consider a new Town Hall as part of the Downtown Phase II Project. She expressed concerns regarding density in Phase II, and she questioned moving forward without the results of a traffic study and a Brandywine Creek tributary stormwater study. She encouraged Council to slow down the development process, so these issues can be understood before moving forward.

Mr. Joe Mulligan, 33 Owen Brown Street, suggested the City's web site provide improved information. He commented that Owen Brown St. residents are skeptical that potential traffic increases will be eased by removal of Hudson Public Power, Windstream, and the bus garage facilities. He noted that Owen Brown Street is a through connection on the current plan, and he spoke regarding density, access, and traffic calming measures, and he encouraged staff to explore solutions to address Owen Brown Street concerns. He also said the new street lights on North Main Street are too bright.

Mr. Ron Strobl, 24 Owen Brown St. expressed frustration regarding what he described as a miscommunication concerning traffic study results.

#### A brief discussion followed:

Mayor Basil said that the price of land has yet to be negotiated and determined. He also stated that a traffic count was performed predevelopment, however the City cannot do a traffic study before development plans are finalized.

Ms. Howington acknowledged that the N. Main Street lights are bright, but they will be turned down when the construction work has been completed. She said that the Brandywine Creek study will be done in the fall of 2018 in conjunction with the North East Ohio Regional Sewer District. She said that the City will consider impacts on Owen Brown Street residents as plans for Phase II proceed, and all interests will be balanced and engineered into the final plan. She noted that we are only at the conceptual plan stage, and the developer must do their proformas before a development agreement can be finalized with the City. She acknowledged traffic and parking issues, noting that the City is hiring a consultant to conduct a parking study, and a traffic study will be conducted after residential and commercial densities are determined. She said that the concerns now being expressed are exactly the concerns that need to be considered during the lengthy development process. In addition, she said that the City is working on updates to the web site.

#### 7. Correspondence and Council Comments

Mr. Hanink said that he's been working with the City Engineer since before Downtown Phase II, and he supports keeping Owen Brown Street as is. Mayor Basil commented that City officials want to protect and preserve the character of Owen Brown Street.

Mr. Hanink was pleased to see positive Velocity Broad Band operating numbers for the third month in a row, and Mr. Wooldredge agreed that this was very encouraging.

Mr. Wooldredge provided a draft Resolution in support of the Schools' Bond Issue, which will appear on the November 7th Ballot, and he asked that this matter be discussed at an upcoming workshop.

#### 8. Report of Manager

Ms. Howington provided a brief update on some of the City's current projects, including the painting of all hydrants on Akron and Cleveland water systems; roadway paving and construction of crosswalks and bump-outs on N. Main Street; and completion of the State Route 91 / Prospect Road intersection by Labor Day.

#### Mayor Basil read the title of Ordinance No. 17-115, which constituted its third reading.

Mr. Hanink agreed, noting that additional discussion is necessary regarding EMS operations and billing to ensure long-term sustainability for EMS. Mrs. Bigham agreed. Mr. Hanink said that he prefers removing all percentages and making Council in charge of allocating resources. Discussion followed regarding timing, and Mr. Hunt said that the deadline for passage will be early Feb. for the May 8, 2018, Ballot. Mayor Basil said that this Ordinance could be discussed at a workshop before coming off the table.
