Discussion included: PCI process, which is performed every 2 years; resurfacing budget versus monies needed to keep road ratings up; changes to AMATS scoring and process; use of license tax and permissive tax dollars; efficiencies that have been utilized to save money;

possibility of bonding the asphalt overlay of concrete streets; adding \$50,000 to the Public Works Department patching fund, Council members suggested using up all of the initial \$50,000 budget, and if needed, more money could be appropriated; and sidewalk connectivity.
