6. Discussion Items

A. [17-0098](#) Economic Development Update

Executive Summary: Staff will provide overview of recent employer growth, industrial park gains, and potential development in Districts 6 and 8.

Mr. Stifler provided an update on Economic Development. Discussion topics included Velocity Broadband, Hudson's brand and marketing, and development in the following areas, Hudson Crossing Business Park, Seasons Greene Eco-Industrial Park, Downtown Phase 2, Boston Mills Road areas, Districts 8 and 9, and the former Youth Development Center property. Other items discussed included radio advertising, the Intelligent Community Forum, and the City's outreach to local executives.
