1. Call to Order

3. Resident Input

Ms. Bigham, Council Liaison shared appreciation from Mr. Louis Verhas of 1701 Groton Drive about nearby Middleton Park.

Vic Hamer of 27 Hickory Lane and Mike Bird of 7406 Hudson Park Drive representing Live Healthy, Live Hudson - Leadership Hudson, Class of 2016 talked about the fitness trail at Cascade Park.

The Park Board will recommend to Council that we match funds up to 50% of the total cost \$34,398 for the fitness trail at Cascade Park that was presented by Live Healthy, Live Hudson - Leadership Hudson, class of 2016.

B. Environmental Awareness Committee

Jeff Wells and Jack Brookhart from the Environmental Awareness Committee came to talk about a partnership to bring recycling cans back into the parks. In spring, cans provided by a Summit County grant were removed from the parks. EAC wants to work with the Park Board to return recycling to the Parks. Gene Fitch volunteered to work with the EAC on this project.

C. Kate Chapel, watershed coordinator, Tinkers Creek Watershed Partnership

Ms. Chapel reported that a grant for Darrow Road Park has been received for \$31,000 for Education and Outreach in that park. Another grant is out currently for stewardship of Darrow Road Park which includes planting natives and removing invasive species. Included in that grant application, Ms. Chapel has requested money for a conceptual stream restoration for the park. Darrow Road Park is a headwater for Tinkers Creek. She can ask for up to \$35,000 with a match. A conservation easement from the City of wetlands on that property can be used for those match dollars. This means we give up rights to develop approximately 50-acres of the wetland portion of the park. There is an existing trail and restoration of that trail also included in the grant. Westcreek Conservancy would take the over the conservation easement. Ms. Chapel is not in a huge hurry for the matching funds (in the form of the easement) but would like us to eventually move to recommend to Council that we allow the conservation easement at Darrow Road Park. Ms. Chapel will provide a map of the wetlands at Darrow Road Park and the PArk Board will table discussion until a later meeting.

Marsha Carten of Herrick Park Drive, near Darrow Road Park, came to support Kate Chapel's Tinker's Creek project.

5. Asst Superintendent Report

The Colony Park bridge is still a go with LULi construction for chip and seal, and we will be replacing the wood on it in the next two months.

We will be addressing the troubled areas on the Hudson Springs Park trail with new drainage and possibly paving those three areas.

Dredging will be taking place as soon as weather permits at Hudson Springs Park.

We are doing ongoing maintenance for spring.

Working with Trent on the skate park design, shade structure for splash pad and trail at Oak Grove.

6. Old Business

A. Master Plan

Next meeting put together timeline to have new Master Plan complete. Time at each meeting to discuss. Mr. Wash suggested a 30-page strategic plan instead of 112 page Master Plan. Mr. King suggested a new survey to get community input of under-served sports, if more ball fields are needed, trail priorities, etc.,. Come prepared with questions and comments on the current Master Plan.

Lands Swap with MetroParks for an area connecting Hudson Springs Park to route 303. Mr. Smith will spearhead this effort.

7. New Business

New contact list will be distributed.

Data and draft agenda will be distributed 1 week prior to meeting to review by members.

Keith Smith would like to attend Council workshops in our off months to improve communication between Council and Park Board. Mr. Wash will see about that possibility. Ms. Bigham can take an executive summary to any council meeting and she can provide Council feedback from his update on the agenda each month.

Mr. King thinks this trail should be incorporated in the redesign of the service center. Hinting Hollow and bridge on wetland.
