Executive Summary: Per the approved 2015 fleet capital replacement budget the Public Works Department has obtained competitive pricing for the purchase of two (2) replacement snow plow truck cab and chassis . The replacement cab and chassis will be purchased from Valley Freightliner Trucks of Cleveland. Each replacement unit will need to be out fitted with snow plow and dump bed equipment. As such, the associated equipment will be purchased and installed by Henderson Truck Equipment-Ohio.

A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A PURCHASE AGREEMENT FOR TWO SNOW PLOW TRUCKS (CABS AND CHASSIS) AND AN AGREEMENT FOR THE PURCHASE AND INSTALLATION OF SNOW/ICE REMOVAL EQUIPMENT; AND DECLARING AN EMERGENCY.

Executive Summary: Per the approved 2015 fleet capital replacement budget the Public Works Department has obtained competitive pricing for the purchase of two (2) replacement snow plow truck cab and chassis . The replacement cab and chassis will be purchased from Valley Freightliner Trucks of Cleveland. Each replacement unit will need to be out fitted with snow plow and dump bed equipment. As such, the associated equipment will be purchased and installed by Henderson Truck Equipment-Ohio.

Legislative History

Resolution 14-155, permission to seek bids and competitive pricing for the 2015 budget year.

Purpose & Explanation

As per the 2015 approved fleet capital budget, replacement snow plow cab and chassis will be purchased from Valley Freightliner Trucks of Cleveland. The purchases are based on the current ODOT purchasing contract number 023-14. The units being replaced (Trucks #7750, 7752) will remain in the fleet and be utilized as backup units for snow plowing operations.

Each replacement unit will require the installation of snow plow and dump bed equipment which will be provided and installed by Henderson Truck-Ohio per the National Joint Powers Alliance (NJPA) contract # 0801140-HPI-2015-2. (See attachment pricing chart).

Timing Considerations

Staff requests emergency legislation to hold pricing and expedite vehicle and equipment orders.

Suggested Action

Staff recommends City Council authorize the City Manager to enter into a purchase agreement with Valley Freightliner Trucks of Cleveland 4985 W. 150th St. Brookpark, Ohio 44135 in the amount of \$174,784 for the purchase of two (2) 2015 Freightliner 108SD Cab & Chassis.

Staff further recommends City Council authorize the City Manager to enter into a purchase agreement with Henderson Truck Equipment - Ohio 2177 State Route 19, Bucyrus, OH 44820 in the amount of \$142,216 for the purchase and installation of snow removal equipment to be installed on both replacement cab & chassis.
