A RESOLUTION AUTHORIZING THE CITY MANAGER TO EXERCISE A RENEWAL TERM IN A CONTRACT WITH CARDINAL ASPHALT COMPANY, INC. FOR ASPHALT STREET REPAIRS.

Executive Summary:

The Public Works Department budgets annually for contract asphalt road repairs for city streets. The current contract is a two (2) year term with an option to renew and extend the contract for an additional two (2) years if the work performance is acceptable and the pricing remains reasonable. The Public Works Department seeks City Council approval to renew the current asphalt contract for an additional two (2) term with the Cardinal Asphalt Company.

Legislative History

Resolution 14-155 to advertise for bids including asphalt full depth replacement road repairs.

Purpose & Explanation

The Service Department patches city streets with cold patch material in the winter months and Dura-patch emulsion in the summer. In some cases certain areas beyond temporary repairs are scheduled for full depth removal and replacement by a specialized asphalt contractor.

Cardinal Asphalt Co. has performed very good work for the City under the existing contract and has submitted no increase in pricing to renew the contract per the contract language. A bid tabulation has been attached for review.

Staff wishes to renew the existing contract for an additional two (2) years.
