Purpose & Explanation

During construction of the Ellsworth Hill Safe Routes to School Sidewalk Project along Parkside Drive, additional expenses will be incurred above and beyond the 10% contingency amount originally approved by Council. The additional expenses are for additional storm sewer installation, grading of drainage ditches and restoration along several roadside ditches in front of several homes.

The total amount that City Staff is requesting is \$8,000.00.

Upon authorization to proceed by the City Council, the administration will issue a Change Order to the contract
