Resolution No. 14-80, Authorizing the Purchase of Two Pierce Pumper Trucks for the Fire Department, passed June 18, 2014.

Resolution No. 14-162, Expressing the Intent of the City of Hudson in 2015 to Sell by Internet Auction Personal Property, Including Motor Vehicles and Other Property Referenced in Revised Code §721.15 Which Are No Longer Needed for Public Use or Are Obsolete or Unfit for the Use for Which They Were Acquired, passed December 17, 2014.

#### Purpose & Explanation

In May 2015, the Fire Department accepted delivery of two new fire engines, replacing two 1994 engines (see attached description). The City would like to sell the old fire engines, which are no longer needed for municipal purposes. City Council will consider the City of Ravenna's expression of interest in purchasing one of the 1994 fire engines for a sum of \$32,000, "as is" with no expressed or written warrantees (see attached letter).
