#### Purpose & Explanation

The Hudson Tree Commission has asked the City of Hudson to apply for a grant for \$2,400 to water flower pots and hanging baskets on North Main Street from Park Lane to Owen Brown Street. The funding would help cover the cost of hiring a contractor to perform this task, which is estimated to cost \$7,000 for the growing season and is currently budgeted.
