Purpose & Explanation

Bids were received on January 26, 2016 for the Oak Grove Park Lighting Project. Below is the Engineer's Estimate along with the respective bids.

Engineer's Construction/Installation Estimate: \$70,574.60

The City Administration is requesting City Council approval to authorize the City Manager to award and enter into a contract with Emery Electric, Inc. for the Oak Grove Park Lighting Project. Staff is requesting a 10% contingency for any unforeseen issues that may arise during construction. The total amount would be \$76,723.13.

Total Contract = \$76,723.13 (\$69,748.30-base + \$6,974.83-contingency)

Upon authorization to proceed by the City Council, the administration will award and enter into a contract with Emery Electric, Inc. for the above amounts.
