#### Purpose & Explanation

The Ohio Department of Natural Resources has requested a Resolution obligating the City of Hudson's portion of the construction costs of Phase I of Veterans Trail. The City has applied for \$850,000 in grant funding, on behalf of the Hudson Parks, towards the estimated \$1,462,994.50 cost.
