#### Purpose & Explanation

Staff is seeking funding from the Ohio Bureau of Workers' Compensation through a Firefighter Exposure to Environmental Elements Grant to fund the purchase of hoods with barrier protection. Staff will purchase 40 hoods with grant funding at a cost of \$3,600.00. The grant amount would be \$3,000.00. The Hudson Fire Department's match would be \$600.00. Each fire department is eligible for \$15,000 in funding. The Fire Department received funding for a new washer/extractor and is attempting to use the remaining funds before they run out.
